# Security Committee: Jack Bramson

The following information is the Security Committee Report for the reporting period of March 2016:

The King County Sheriff's Office performed 9 dedicated patrol shifts within Fairwood Greens during the month of March with primary emphasis on traffic control and enforcement, and neighborhood checks. These patrols resulted in the following:

- (2) NOI issuance (citations for traffic infractions)
- (3) warnings issued for traffic infractions
- (1) unauthorized solicitor contact

In addition, KCSO performed a No Trespass Order issuance and responded to several other calls for service.

The Securitas contract security report showed no significant changes to normal occurrence or activity.

#### External Affairs: Diana Garcia

1. The Board received correspondence from Save Habitat and Diversity of Wetlands, or SHADOW Lake Nature Preserve. Located in Renton, the preserve features over three miles of trails through unique wetland habitat, including 5,000 year-old Shadow Lake Bog. SHADOW hosts a variety of educational programs and community events, including volunteer restoration work parties and low-cost naturalist workshops.

The preserve included their Spring Events Calendar, which we will post to our FGHOA website for homeowner reference.
