Security Committee: Jack Bramson

The following is the FGHOA Security Committee Report for the June reporting period.

The King County Sheriffs Dept. performed 10 Fairwood Greens dedicated patrol shifts which emphasized traffic enforcement and neighborhood high visibility patrol activity. These patrols resulted in the following:

- 10 Traffic enforcement warnings
- 3 Traffic citations (NOI's) being issued for violations

14 Citizen contacts

1 Citizen assist to help find lost children and their friends

There were two reports of stolen vehicles being recovered in Fairwood Greens as well as one residential burglary and a stolen vehicle.

The warmer weather has likely contributed to the increase in open garage door reports. All residents are encouraged to remember to secure residences and garages to prevent theft and burglary.

The current security services contract expires in September. It is recommended that we reengage Securitas' services for the next contract year to be brought up for a vote at the June HOA Board/Trustee meeting.

External Affairs: Diana Garcia

The Fairwood area Town Hall meeting on June 2nd was well attended. The meeting is hosted within several unincorporated King County areas by Councilman Reagan Dunn's office, with participation by Sheriff John Urquhart, and multiple King County offices including the Assessor, Transportation, National Resources & Parks, Permitting & Environmental Review, Public Health, and the Office of Emergency Management.

The Fairwood Greens HOA was highlighted as receiving one of 2016's Community Service Area grants, which supplement our annual August Music in the Park series.

Sheriff Urquhart spoke about overall statistics in the Fairwood area, including budget shortfalls. The Sheriff's office is responsible for responding to 250,000 residents in unincorporated King County. 76% of the Sheriff's office budget comes from the general fund. In 2016 they had a \$25 million budget shortage and the 2017 fiscal year is projected to have a \$50 million budget shortage. Sheriff Urquhart confirmed that no patrols or detectives will be cut.

Crime data from 2015 was reviewed. There were 2 homicides. Residential burglaries, drug arrests, and car prowls all decreased. Felony assaults increased.

John Wilson provided an overview of the Assessor's office, which is responsible for 750,000 parcels (both residential and commercial) in King County. He indicated that there is a need to modernize the tax system. Low income seniors may be eligible for a partial exemption in their taxes. To see if you qualify, please contact the Assessor's office.

Harold Tanaguchi from the Department of Transportation noted that the department is focusing on safety and priority maintenance and no new projects are scheduled due to limited resources. Several questions were asked about

transit in the Fairwood area and Mr. Tanaguchi indicated that transit is dependent on sales tax.

John Taylor from the Department of Natural Resources & Parks provided an overview of how different areas within the DNRP are funded. Solid waste rates are set by the King County Council, parks levies are voter-approved, and surface water management collects fees through Cedar River Water & Sewer. The Parks Department has completed an inventory assessment over the past 2 years to help prioritize work. The Parks Department-sponsored Fairwood 50th Anniversary Celebration was discussed. This event will be held on August 27th at Petrovitsky Park and will include many activities for residents.

Wally Archileta from Permitting and Environmental Review highlighted the new online permitting feature and pre-submittal services designed to improve speed-of-service. He indicated that 180th will be closing for 3-4 weeks later this summer, with a detour planned while work is being completed. Additionally, he noted that a hearing on the Addison Park sub-division will be scheduled in August.

During the Public Comment period, many issues were brought up by residents, including diversification of Sheriff deputies, Domestic Violence & Human Trafficking, zoning of large assisted-living facilities, perceived drug/nuisance house in Fairwood Greens, regional coordination for road capacity improvements due to the increased traffic/growth in Fairwood, the new development of homes facing onto 140th Avenue which is creating traffic impacts, bus/transit requests for Express service into Seattle, plans to increase capacity on I-405, how to encourage business opportunities in Fairwood, and off-duty Sheriff deputies being able to use the ACCESS system to look up vehicle information.

Cedar River Water & Sewer provided a report of several capital improvement projects which will improve the reliability of the water and sewer system. One of these improvements is a sewer trunk line in the Fairwood area which is being replaced and will greatly reduce the maintenance of the sewer system in the area. This project was begun in May and will be completed by the end of September. Minor interruptions of water service may be encountered, but customers will be notified prior to any interruptions.
