## Security Committee: Jack Bramson

The following is the security committee report for the reporting period of July 2016:

The King County Sheriff's Office performed 16 dedicated Fairwood Greens patrols during the month. In addition to neighborhood patrol and visibility, these patrol shifts resulted in the following:

- 5 NOI's (citations) issued for traffic infractions
- 34 Traffic warnings issued
- 53 Citizen contacts
- 30 Parking violation warnings issued
- 3 Other activities including a criminal citation issuance; stolen vehicle recovery and stolen vehicle area search

Deputy Sam Shirley provided the burglary prevention guidelines. Residential burglaries usually spike in the summer months as they are other a crime of opportunity; open windows and doors create the opportunity.

The monthly Securitas report shows a slight increase in both trespassing and solicitors.

# **Burglary Prevention**

Many burglaries are crimes of opportunity. With the hot weather, you may leave doors or windows open to combat the heat. Some people leave their garage doors or front doors open while outside or in the back yard. Open doors and windows are invitations to burglars.

- Keep doors and windows locked when you are not home.
- Be aware of what parts of your home are locked when you are home (is your garage door open while you are mowing your back yard?).
- Set your alarm when you leave, even on short trips during the day. Most residential burglaries happen during the day.
- Use timers on lights and radios. Make the burglars think you are home.
- Don't ignore people knocking on your door. Many burglars knock first to determine if someone is home. If you don't want to talk with them, don't, but let them know you are there. Burglars usually don't want to enter an occupied home. Once they know you are there they will most likely leave.
- Keep shrubs trimmed back from windows and doors. Burglars like privacy.
- Leaving on vacation? Let Securitas know! They can keep an eye on things for you while you are gone. Stop your mail and newspaper delivery or have someone you trust pick it up.
- Ask your neighbor to use your driveway to park while you are gone.
- Secure sliding doors with a pin to lock the doors together when they are closed. This prevents the door from being lifted out of the track.
- Report suspicious people or vehicles to Securitas. If you think you see a crime in progress, call 911 immediately.

Vehicles and recreational vehicles of any type cannot be parked or stored on the grass or ground of the front and/or side yards.
