As of the 8/21/17, the reporting stats from the King County Sheriff's dedicated patrols are as follows:

- (1) Notice of Infraction traffic citation issued
- (9) Traffic related warnings issued
- (7) Parking related warnings issues
- (6) Other types of patrol/enforcement incidents including one arrest and several suspicious subjects being contacted
- (4) Initiated citizen contacts

Four patrol shifts were conducted during other than daytime hours. These contracted patrol shifts are intended to create high visibility of law enforcement in our community to keep our neighborhood safe

The Securitas monthly security activity report showed an increase in abandoned vehicles, trespassing, and vehicle vandalism.

All Fairwood Greens residents are reminded to lock your vehicles, and to keep valuables either out of sight or not in the vehicle at all. You are urged to report ALL crimes to the King County Sheriff's office and not only to Securitas.
