Executive Committee: Jim Canterbury Month – <u>November 2016</u>

Reminders:

1. Homeowners should clean tree leaves/debris from the storm drains in the street by their homes. This will help prevent street flooding and water getting into homes and/or basements and possibly prevent a vehicle accident from hydroplaning.

2. Some areas of our neighborhood had an ongoing infestation of rats and raccoons this year. Homeowners should not put out food scraps to feed the squirrels and crows as it only invites other rodents (mice & rats), raccoons, and black bears to the neighborhood. It not only increases the rodents around, inside or under your home but it also affects your neighbors' property. Let's all be good neighbors and not feed the wildlife animals as it is against the King County code title 8.06

3. Recently there have been reports of mail/package thefts from within the Fairwood Greens community. Please be vigilant and aware that when putting outgoing mail into your mail box with the red flag up represents an opportunity to many other than the mailperson. Also, be aware of packages delivered by USPS, UPS or Fed Ex to your front door this time of year. A package left at the front door it is a crime of opportunity if not picked up timely.

Here's some information from the King County Sheriff's Website about identity theft:

Protect against identity theft by being vigilant about the security of your mail. Many identity thieves target home mailboxes and steal mail because it often contains valuable personal and financial information.

- Do not place outgoing mail in your home mailbox. Deposit it directly in a secure mailbox.
- Install a locking mailbox to receive all incoming mail.
- Pick up new checks from the bank in person instead of having them mailed to you.
- Shred any pre-approved credit card applications delivered to your home.
- Stop mail delivery to your home when you are on vacation by using <u>www.USPS.com</u> or <u>www.FedEx.com</u>. (external link).
- Request a signature on delivery. No Signature the package company will require pickup at their facility.

If you see anything suspicious, call 911 immediately (King County Sheriff) and call Securitas (local roving officer) at 425-221-8170 to report. Also, try to get vehicle description and license plate number.

Many homes have installed personal locking mailboxes as protection. Information about locking mailboxes can be found on the Fairwood Greens website (www.fairwoodgreens.org) under "FAQ".
