Government/Guests Reports to the Board

King County Sheriff's Department: Sergeant Thomas Collins No package thefts were reported to us last month. One was reported to Securitas. If a package theft occurs, call our non-emergency number at 206-296-3311, then call Securitas.

Four men were found smoking marijuana in the back area of Toddler park. If you see suspicious persons going to the back of Toddler park call us and Securitas.

A homeowner complained of people parking in the posted no parking areas on SE 176st ST. Sergeant Collins stated he would notify the district cars in the area to watch for this.

A homeowner thanked Sergeant Collins for checking for downed power lines after the wind storm.

Renton Regional Fire Authority: Battalion Chief/Safety Officer Mike Pruitt Professionally clean heating systems. Clean storm drains, downspouts and chimneys. Change batteries in smoke detectors. Disconnect water hoses for the winter. Insulate plumbing and pipes. Trim trees. Have an emergency kit with flashlights. Check baseboard heaters are free of items. Check that space heaters have a tip over/turn off feature. Close screen and door when using a fireplace. Wait a couple of days before cleaning the fireplace to be sure embers are extinguished.

Significant incidents in the general area included six residential/structure fires of which four were vehicle fires, one was a kitchen fire, and one a flash fire. We responded to five emergency calls of which four were vehicle accidents and one was a shooting.
