9. Base Positions to be filled (Todd Holmes) – There are several positions which need to be filled.
 - a. Secretary - Darrin Husmann was elected but has been given additional duties at work that prevent him from taking office. Per our base By-Laws, the Base Commander must appoint a person to fill this. Until a volunteer is found, Dale will continue to fulfil these duties.
