FULL TEXT

An Edmonton man has admitted using an axe to attack a person who earlier supposedly jumped him for no reason outside a Mill Woods lounge last summer.

Michael Polacsek, 20, pleaded guilty to assault causing bodily harm Friday in provincial court.

Crown prosecutor Scott Niblock said Polacsek was at the Live Wire Bar & Grill, 1107 Knottwood Rd., with his brother on July 26 and had gone outside for a smoke when he was apparently jumped by Jonas Wurtz.

A security camera shows Polacsek being held in a headlock and then thrown onto the hood of a car before a number of people in two groups swarmed each other.

Polacsek and his brother were chased away from the area and ended up hiding in a nearby backyard, court heard. They then spotted some garden tools and returned to the bar several minutes later armed with an axe and a hoe.

Kyle Polacsek, 22, allegedly hit Wurtz a couple of times with the hoe and then his younger brother struck Wurtz once with the axe before they fled the scene.

Wurtz, who allegedly took Michael Polacsek's New York Yankees ball cap, suffered a 10-cm long cut to the lower back and three or four cuts across his head.

Defence lawyer Gloria Hammermeister told court her client was not the instigator in the initial fight, but conceded he returned armed with an axe and used it.

"He went to sing karaoke after going to a concert at Northlands and was attacked," said Hammermeister. "The problem was he went back with an axe."

Hammermeister also told court Polacsek is a student who is very punctual and does not have a criminal record. She said he "definitely deserves a second chance."

A pre-sentence report and a psychiatric assessment were ordered and a sentencing hearing was set for Aug. 11.

Meanwhile, Kyle Polacsek is slated to go to trial on charges of aggravated assault and possession of a dangerous weapon on Aug. 12.
