**SUPPLEMENTAL AFFIDAVIT OF CHASITY PHILLIPS**

I, Chasity Phillips, of Edmonton, Alberta, SWEAR AND SAY THAT:

1. I am one of the two named Applicants in this Judicial Review proceeding, a maternal aunt of Eric Omeasoo ("Eric"), a daughter of co-Applicant, Rhonda Spence, and the creator of the website, JusticeForEric.com.
2. On February 21, 2025, along with other members of Eric's family, we collected Eric's clothes from the funeral home. Attached and marked, as noted below, are copies of photographs taken of Eric's clothes:
  - a. **Exhibit "1"**: a photograph of Eric's jacket and the identification marker "A", and the surrounding cut to Eric's jacket;
  - b. **Exhibit "2"**: a photograph of Eric's jacket and the identification marker "B", and the surrounding cut to Eric's jacket;

- c. **Exhibit "3"**: a photograph of Eric's jacket and the identification marker "C", and the surrounding cut to Eric's jacket;
- d. **Exhibit "4"**: a photograph of Eric's jacket and the identification marker "D", and surrounding cuts to Eric's jacket;
- e. **Exhibit "5"**: a photograph of Eric's jacket and the identification marker "E", and the surrounding cuts to Eric's jacket;
- f. **Exhibit "6"**: assorted photographs of Eric's hoodie, inside and outside, as well as the sleeves, showing blood on the inside of the hoodie where Eric had been cut on his back before he died;
- g. **Exhibit "7"**: assorted photographs of Eric's black jeans showing cuts to the upper right leg/outer groin area;
- h. **Exhibit "8"**: assorted photographs of Eric's underwear showing multiple cuts along the bottom edge on the right leg, corresponding to the cuts in his jeans; and
- i. **Exhibit "9"**: assorted photographs of Eric's black t-shirt, which was cut open, presumably by first responders or at the medical examiner's office, and which also appears to have been torn at the top collar on the back right side.

#### **Crime Scene Setup Observed**

- 3. Attached and marked as noted below are:
  - a. **Exhibit "10"**: A recording I made of a live reel posted by [REDACTED] a local vlogger, with their consent. I am informed by [REDACTED] and believe that this reel was made at approximately 9:00 am on February 6, 2025, while EPS officers were placing evidence markers and gathering evidence; and
  - b. **Exhibit "11"**: Screenshots from my discussion with [REDACTED] about what they observed the morning of February 6, 2025 at the MacEwan LRT station while out walking their dog.

#### **Impromptu Meeting with Mikaelah Hudson and Michael Lucier**

- 4. Attached and marked as **Exhibit "12"** is a copy of the video recording that I made of my and Rhonda Spence's impromptu meeting with Mikaelah Hudson and Michael Lucier at a bus stop we passed by and stopped to speak first with Mikaelah Hudson when we happened to see her there.

#### **Crown Witnesses in Brad Alook trial**

- 5. I attended the Edmonton Law Courts Building on September 8, 2025 with Rhonda Spence to pick up some court documents. As we were leaving, Rhonda and I saw Michael Lucier and Mikaelah Hudson with an EPS officer about one block from the courthouse. We drove by and



said Justice for Eric to them as we passed by them walking with EPS accompaniment to the Courts.

6. Attached and marked as [REDACTED] is a copy of the video recording I made of our drive by Michael Lucier and Mikaelah Hudson as they were outside and marked as [REDACTED] is a copy of the video I made while they were being cleared through security, though I missed catching Michael Lucier completing the security screen upon entering.
7. Rhonda and I parked our vehicle and went back to the Courthouse. We realized that Michael Lucier and Mikaelah Hudson were giving evidence at the preliminary inquiry for a trial about the murder of Joshua Cardinal.
8. At one point, security forced Rhonda and I to leave the preliminary inquiry and I made a complaint about this, a copy of which is attached and marked as [REDACTED] I was contacted about this complaint in a very professional manner, although I was too unwell at the time of the follow up to be able to discuss it.

#### **Media Coverage of EPS Press Releases and Justice for Eric Release**

9. Attached and marked collectively as [REDACTED] are copies of media articles based on EPS press releases about Eric's homicide and the events at MacEwan LRT shortly before midnight on February 5, 2025:
  - a. February 6, 2025 article published by CTV ;
  - b. February 6, 2025 article published by Global;
  - c. February 7, 2025 article published by CTV;
  - d. February 10, 2025 GoFundMe coverage and information from the EPS Press Release;
  - e. March 4, 2025 article published by CityNews;
  - f. March 4, 2025 article published by CTV News.
10. Attached and marked as [REDACTED] is a copy of the March 3, 2025 Release that I prepared and posted on social media and sent it to multiple news outlets at Legacy Media.
11. On February 7, 2025, Global News reported on the residents' reactions to Eric's homicide. During this news broadcast, one of the reporters called the altercation a deadly swarming and subsequently, then showed images of the police laying out Eric's body bag. Attached and marked as [REDACTED] is the video of Global News Hour at 6 Edmonton (the "**Global Video**").
12. I am continuously haunted by the Global Video, as well as the February 6, 2025 Global article which shows Eric's body bag being propped up on an ETS bench.

## Child and Youth Advocate

13. On September 25, 2025, Rhonda Spence and I attended the Office and the Child and Youth Advocate ("OCYA") in the hopes of better understanding their office's role in Eric's murder. We were able to meet with the investigator that had been assigned to Eric's file. I was informed through my communications with the OCYA and believe that:
  - a. The OCYA did have a file on Eric;
  - b. The investigator had completed their file review on September 24, 2025. This is the first step in a sequential process that includes a second investigator reviewing Eric's file, ultimately concluding with the publication of a public report about Eric's death;
  - c. The OCYA's goal is not to find fault or assign any responsibility regarding the death of the young person they are investigating; and
  - d. The investigator began working on Eric's file in mid-July 2025. OCYA confirmed that Eric's death was not reported to them and was flagged on a generic list of deaths.
14. I made an audio recording of that meeting, attached and marked as [REDACTED] is a copy of the first part of the meeting. Attached and marked as [REDACTED] is a copy of the second part of the meeting.
15. As at the date of making this affidavit:
  - a. No report on Eric's death has been published by the OCYA; and
  - b. We have not been contacted by the OCYA for any formal interview in their investigation into Eric's death.

## Autopsy Report and Funeral Home Records

16. [REDACTED]
17. I attended with Rhonda Spence at the OCME and made an audio recording of that meeting, a copy of which is attached and marked as [REDACTED]
18. I was informed through my communications with the OCME and believe that:
  - a. EPS did not arrange for a medical examiner from the OCME to attend with Eric after he was pronounced dead until the morning of February 6, 2025;
  - b. The individual who came to the LRT station from the OCME was not Daniel Smyk, who performed the autopsy;
  - c. The medical examiner who completed Eric's autopsy, Daniel Smyk, did not take any of the photos of Eric's body on which he relied.



19. When viewing Eric's body, I was alarmed by a number of things not noted in the autopsy report, or not detailed where some aspect of it is noted, including, but not limited to:
- a. The dark, mud-like substance which contained rocks and pebbles, that formed a ring around Eric's mouth, and was caked on his hands and under his nails, as if he had been digging or clawing something dirty but also sticky-like, as the substance did not go away when his hands were cleaned;
  - b. Eric's nose was bruised and looked broken with a bump on the bridge of his nose, but the medical examiner said they were not;
  - c. Eric's face had bruising and light scrapes on his left side;
  - d. Eric had a goose-egg-like contusion on his right cheekbone;
  - e. Eric's knees were scraped and bruised;
  - f. Eric's fingers had a number of cut lines horizontally across them, which the medical examiner characterized as scrapes or abrasions though they were not documented in the autopsy report; and
  - g. There were marks that looked like puncture wounds on Eric's back although they are not documented in the autopsy report and one of the doctors debated what they were from a review of only the photos. These same marks no longer appeared after Eric's body was washed. The Deputy Chief Examiner told our family that the water washed the marks away.
20. Attached and marked as [REDACTED] is the Preparation Room Report by Connelly-McKinley Ltd. Funeral Home.
21. Attached and marked as [REDACTED] on the night of Eric's death.

**Purpose of Affidavit**

22. As at the date of making this affidavit, neither myself or Rhonda Spence have ever been contacted by anyone from the Alberta Crown Prosecution Service.
23. I make this Affidavit in support of the November 18, 2025 threshold hearing for this Judicial Review proceeding brought by myself and Rhonda Spence.
