

I, [REDACTED] of Edmonton, Alberta, SWEAR/AFFIRM AND SAY THAT:

1. I am a resident of Alberta over the age of 18 years and make this affidavit voluntarily and of my own free will. In this Affidavit I have set out my recollection of events I observed on February 5, 2025.
2. I arrived at the MacEwan LRT station on February 5, 2025 late in the evening to meet a friend. When I arrived, I went to the train platform and sat down on a metal bench located outside the enclosed glass warming area located in the middle of the platform.
3. I was facing Roger's Place while sitting on the bench. Attached and marked as **Exhibit "1"** is a photograph of the MacEwan LRT platform shown to me by Sharon Robets, who I understand to be legal counsel for the Applicants. The photograph shows the bench where I was seated while I waited for my friend to meet me at MacEwan LRT station.
4. When I am out late at night by myself, I wear headphones and listen to music. On that night, while waiting alone, I was listening to a playlist that I put together myself. Even

though I listen to my music loudly, I could hear argumentative shouting inside the enclosed glass warming area on the platform.

5. The glassed-in area was directly beside where I was sitting. Inside, I noticed a man and a woman arguing. I am informed by Sharon Roberts, who I understand is a lawyer for the Applicants, and believe that the man's name is Michael Lucier, and the woman's name is Mikaelah Hudson.
6. At the same time as I saw Michael Lucier and Mikaelah Hudson arguing, I saw another male, younger than the arguing couple, walk into the enclosed glass area. The couple stopped arguing and were quiet very briefly. Then the couple started to yell at the young male. I did not observe the younger male arguing with the couple.
7. Attached and marked as **Exhibit “2”** is a photograph shown to me by Ms. Roberts, which I recognize to be the young male I described. I am informed by Ms. Roberts and believe the young male was Eric Omeasoo (“Eric”).
8. I had the sense that the younger male did not leave the enclosed glass area because the couple were intimidating him. Shortly after I noticed this, Eric and the couple all moved outside of the enclosed glass area and were standing on the yellow strip that runs close to the tracks on the LRT platform, very close to me.
9. Michael Lucier was shouting at Eric. Mikaelah Hudson yanked Michael Lucier and he spun around to face her. I could not make out what they were saying to each other. Michael Lucier pushed Mikaelah Hudson and she pushed him back. Their argument continued as they moved behind me, on the side of the platform that is closest to the park, opposite from Roger's Place.
10. I am not certain of the time, but I believe approximately 20 minutes passed. I got up to leave because my friend did not show up. As I left the area of the bench to walk off the platform, I saw Michael Lucier chasing Eric toward the edge of the platform closest to the park, away from the Rogers Place side that I had been facing.
11. I also saw Michael Lucier push Eric and then saw both of them fall off the platform, down to the track level, on the side closest to the park. I then slowly walked toward the far west end of the LRT station, away from where I had seen Michael Lucier and Eric fall.
12. As I was leaving the station, I originally planned to head left where the path divides, toward downtown. I had been walking slowly, as I was texting my friend to find out why she had not come or if she may still be coming. Suddenly I had a gut-wrenching feeling in my stomach and felt that I should turn around and look back.
13. As I turned around, I walked part of the way back toward the LRT station. I thought I saw something under the platform edge; as I walked closer, I realized with certainty that it was a person lying face down on the ground. I saw the person's body, not moving, and tucked very close up against the wall of the LRT platform, underneath the part of the platform that hangs over the base.

14. Attached and marked as **Exhibit “3”** is a photograph marked with a red “X” where I saw the person’s body, tucked under the platform, against the wall of the platform base. I looked around, and did not see the couple, Michael Lucier and Mikaelah Hudson, who had been arguing earlier.
15. I saw an oncoming train, and tried to signal the driver that someone was underneath the platform. The driver did not stop, or seem to notice me, even though I was waving and pointing, mouthing the words “there is someone down there”. The train stopped at the MacEwan station, but no one got on or off the train, and it continued past me.
16. At around the same time as that train left the station, an adult male in uniform with a cap that looked like the hats that police officers wear jumped off the LRT platform, down to the track level on the same side as where the person’s body was located.
17. Attached and marked as **Exhibit “4”** is an image of a cap that I looked up on the internet, which cap, to the best of my memory, looks similar to the one that the uniformed male was wearing when he jumped off the platform as described in paragraph 14, above.
18. I watched as the male in uniform bent down and appeared to be going underneath the platform, at which point I turned around and walked toward downtown as I believed that the uniformed male was going to help the person who was tucked under the platform, beside the LRT tracks. I did not see whether he actually went under the platform or had any interaction with the person I saw underneath the overhanging edge of the platform.
19. I make this Affidavit in support of the Judicial Review application brought by the Applicants.




