Food License (FSSAI) Registration

If you are planning to start a new food business then you have knowledge about the Food License or FSSAI Registration and the food related products come under the FSSAI Act 2006 and all the food connected business have to follow the guidelines and regulations under the FSSAI Act. It is responsible for setting the standard and regulations & rules & directly report to health & family welfare, Government of India.

What is Food License?

It is basically a 14 digit registration number which is used by the food linked business & printed on the food products with license number and it is required for each type of the business whether it's a trader or manufacturer or import export etc. If you are concerned in the food processing or food manufacturing or packaging or distributing then its compulsory to required the Food License or FSSAI Registration and FSSAI stands for "Food Safety and Standard Authority of India".

Who Required FSSAI Registration?

It is mandatory for all type of the food related business, even if you are planning to start a food related business by way of food processing or manufacturing then it's required from starting irrespective of the turnover.

It helps you in following way -

Increase your consumer confidence in terms of safety.

Helps in removal of multiple legal policies.

Helps in promote new products.

Types of FSSAI Registration

Basically for all the food related business required legal registration to starting a business in India and in this legal registration business incorporation entity like proprietorship firm or private limited company etc are incorporated. Aloof from this you need extra license like GST Registration or Food License etc. so Food License and FSSAI License are the same.

There are mostly 3 type of the Food License category which is necessary for each food related business.

Basic FSSAI Registration - is required for the small businesses which have turnover less than 12 lakh rupees in a year and turnover is calculated on the yearly basis.

State FSSAI Registration - If you have already the FSSAI essential Registration and cross the turnover of the 12 lakh rupees in a year but less than 20 Cr. rupees then its necessary the FSSAI State License Registration.

Central FSSAI Registration - If you are thinking to export import business or want to supply at the government various department then its necessary the FSSAI Central License Registration and even also required for the large scale turnover more than 20 Cr. in a year.

What is food and safety Department?

It is related to the FSSAI Department it works to farming rules regarding the food related articles and completion of the policies. It also provide the technical and scientific support to the central government regarding the food related articles and it act as collection of the food related data consumption with general consciousness about the Food Standards and Food Safety.

Documents Required for FSSAI Registration

The documents depend on the type of the legal entity and Food License. Documents required for FSSAI registration:-

Personal information of the FSSAI Application Applicant -

PAN Card: Copy of PAN is compulsory identity proof.

Copy of Passport/ Driving License/ Voter identity card / Aadhaar Card (any of the Four)

Passport size Photograph

Registered place of work from where the food business is being operated

The latest Utility Bill(Water/Electricity Bill)

Copy of Rent Agreement(if case of Rented property)

Copy of property paper (if owned property)

Note - It's may be a residential property, there is no problem in that but above documentation are required for the same.

Documents required for Basic FSSAI Registration:

Form-A must be correctly and signed by all directors/ proprietor/ partners /Executive member of society

Statement regarding food safety management system(FSMS) on the letterhead of the firm

Evidence of Income determining the annual turnover of food business operator

Nomination of the person selected by the company in Form No.IX and the copy of Board Resolution

Self statement by Director

Affidavit on Non-Judicial Stamp paper

In addition to the above following documents are also required for Central or State FSSAI Licence:

Duly filled Form – B must be appropriately completed and signed by the directors/proprietor / partners / Executive member of association

List of Proprietor / Partners / Executive Members of association with complete address and contact details.

Constitution of company AOA and MOA

Analysis report as per the nature and business activity of the corporation

Food and safety management

Evidence of Income determining the annual turnover of food business operator

No Objection Certificate from the local authority

List of food category preferred to be manufactured

Production unit Photograph

Any other documents which can be a demand by authority on the basis of the requirement of the business.

FSSAI Registration Form

FSSAI Registration or Food License has mainly 2 types of the forms i.e is Form A & Form B.

Following are the details about the both Forms -

Form A For basic FSSAI Registration - Form A is basic fssai registration form fill up by the food business operator. Its Comprises of an FBOs Business activities.

Form B is required for the State Food License Registration and It is a compulsory form with the required above documents for the state license registration.

How to Apply for FSSAI Registration

FSSAI Registration can be applied online but it's always necessary the professional to submit your application and for that:

- 1. You have to submit above customize FSSAI form with the required details & make the payment of the application via net banking / debit card / credit card.
- 2. Once you make the payment, you will get the confirmation via email & sms with the documents checklist.
- 3. You have to send us the credentials via email as scanned copies.
- 4. Be Relaxed! Your Work is done and our experts will submit your application with the government in professional way and will delivered to you the certificate.

Validity of FSSAI License

FSSAI License is issued by the department for 1-2 year for the same and after that there is renewal procedure of FSSAI License, if you want to check authority or validity of FSSAI License then you can check out here about FSSAI License Number Online

Key Guidelines for the Food License Registration

If any food operator is operating in more than 10 states then it's required the central registration for the registered place of work.

If exporters or Importers apply for the FSSAI Registration then they need IEC Code before the Food License & have to apply on the same address.

The brand owners have to display the FASSI Logo and license number on the food package.
