In return for being allowed to participate in Meals in the Meantime Volunteer Activities, I acknowledge, understand, and agree that neither Meals in the Meantime nor its officers, directors, employees, sub-contractors, sponsors, agents, and/or affiliates shall be liable for present or future claims, demands, costs, or expenses arising out of any personal injury, property damage, or loss which may be sustained by me during the course of time that I engage in Volunteer Activities with Meals in the Meantime.

I acknowledge, understand, and agree that by signing this Agreement that I indemnify and hold harmless Meals in the Meantime and its officers, directors, employees, subcontractors, sponsors, agents, and/or affiliates for my engagement in Volunteer Activities.

I acknowledge, understand, and agree that I assume the risks inherent to Volunteer Activities with Meals in the Meantime. Volunteer Activities that I will be engaging in include, but are not limited to:

- Handling food;
- Loading and unloading trucks and vehicles with food;
- Breaking apart empty boxes;
- Carrying and moving boxes and crates;
- Unpacking boxes and crates;
- Throwing items away;
- Coming into contact with dumpsters and other waste disposal;
- Carrying and setting up tables and chairs;
- Assembling bags of food;
- Handing bags of food to people who come to the pantry;
- Interacting with people who use the pantry's services;
- Directing foot traffic in and outside of the food pantry;
- Directing cars in the food pantry's parking lot for food pickups and drop-offs; and
- Other, similar activities related to the packaging, handling, cleaning, and delivery of food and food items.

I acknowledge and understand that Meals in the Meantime is a food pantry, and that by engaging in Volunteer Activities with Meals in the Meantime, I will be in close contact with various types of food and food items. I acknowledge and understand that this may include food and food items that I am allergic to or have other sensitivities to, and acknowledge and understand the risks involved in coming into contact with such food and food items.



I acknowledge and understand that I am engaging in Volunteer Activities with Meals in the Meantime by my own choice. I acknowledge and understand that if I am performing community service hours, or other such service hours that require proof of my participation, that an authorized agent for Meals in the Meantime will acknowledge my participation in Volunteer Activities and provide their signature as needed.

In exchange for signing this Agreement, I acknowledge and understand that Meals in the Meantime and its agents will make a conscious effort to create a safe environment during the course of Volunteer Activities.
