IMPORTANT INFORMATION

This form is intended for holders of a **valid temporary agent licence** who need to renew their licence for the same purpose for which it was originally issued.

The temporary licence must be valid at the time of the renewal application. Should the applicant fail to file the renewal application before the expiry of the temporary licence, a new temporary agent licence application shall be filed, accompanied with all corresponding documents and fees.

The pilot projet RAC-SER is aimed at acquiring locksmith competencies in view of undertaking a process of recognition of acquired competencies (RAC) in locksmithing at a school service centre. The diploma of vocational studies (DVS) permitting to obtain a regular licence in locksmithing must be obtained within a maximum of 2 years following the initial application of the temporary licence RAC-SER. Any subsequent renewal will be refused.

SECTION A – CONSENT REGARDING PERSONAL INFORMATION

A.1 DECLARATION OF THE BUREAU DE LA SÉCURITÉ PRIVÉE

Who collects your personal information? The collecton of your personal information by this form is done by or on behalf of the Bureau de la sécurité privée. ("BSP").

What are your rights? The Act respecting access to documents held by public bodies and the protection of personal information (CQLR, c. A-2.1) ("Access Act") grants you the right to access and rectify your personal information and to withdraw your consent regarding your personal information held by the BSP. In addition, please note that the withdrawal of a consent for mandatory information will jeopardize the validity of any licence held by an individual.

To whom your personal information is disclosed? Your personal information may be disclosed to:

- the BSP employees who need access to such personal information in the performance of their duties;
- the Sûreté du Québec, or any other police force, to verify that the conditions set out in paragraphs 2 and 3 of section 19 of the PSA, as well as the condition set out in paragraph 2 of section 12.1 of the Regulation under the Private Security Act (r.1) have been met:
- your previous and current employers, the training institutions or bodies you have attended and to the relevant government authorities in relation to your citizenship or immigration to corroborate the truthfulness or accuracy of the documents or information provided as part of your application, as applicable;
- any other person or entity authorized to receive such communication with your consent or under the law, including the Access Act and the PSA.

What means are used to collect personal information? This form can be submitted online through a secure download account offered by the third party "tresorit" whose link is accessible via the BSP website in the My Account section. The use of the services of this third party is for the sole purpose of facilitating the collection through technological means. In addition, it is always possible to use the modes of transmission by mail or in person directly at the BSP.
