The (at least) 10% auction bond shall be forfeited if the full price is not paid by the winning bidder within the prescribed period in the Notice of Award. AB shall be in the form of Cash or Manager's/Cashier's Check from a commercial or universal bank. AB of non-winning bidders shall be returned immediately after the announcement of the winning bidder. And for the winning bidder, AB shall form part of their payment.

The bidder shall submit one (1) envelope containing all the necessary bidding documents and the same shall be signed and sealed.
