FCI Tevis added that a manual monitor would be sufficient to help with cost and also could look for a used one. 2025 Budget draft tabled till next month.

The AA stated that volunteer M. Clark was creating a newsletter for the community and hope to have it out within a week or so.

The Board stated they would like two community members, one commissioner, the administrative assistant to take notes, the Assistant Chief who is also acting as Interim Chief, maybe 2 volunteers and possibly the supervisor of Adventure Medics, who the district has contracted through for medic service.

Good of the Order: FCI Tevis mentioned to the Board that the neighbor, Todd Hunt, would like to move his fence line into the district property by quite a bit. The Board responded that he will need to have a survey done before anything can be discussed as the Board stated they think that fence line is in the correct place.
