AMENDMENT TO SUBDIVISION RESTRICTIONS SUNEAGLE BAY SUBDIVISION

SECTION SEVEN (7) PARAGRAPH #2

STATE OF TEXAS-COUNTY OF WOOD

KNOW ALL MEN KNOW ALL MEN BY THESE PRESENTS:

WHEREAS, the restrictions and covenants for SUNEAGLE BAY SUBDIVISION, Section 7, paragraph 2 is being amended to REMOVE the ONLY CAMPING restriction as noted in the second paragraph of section 7 from the Subdivision Restrictions document. Section 7 will read as follows:

7. Except as provided below, no storage building or boathouse, on any lot shall at any time be used as a dwelling, temporarily or permanently, nor shall any shack be placed on any lot, nor shall any residence of a temporary character be permitted.

Tents, pickup truck campers, van conversions and similar types of temporary camping equipment may not be left on a lot unattended for more than 24 consecutive hours. Lots shall be kept free of litter, rubbish, trash or other debris, and no unsanitary conditions shall be allowed to exist on any lot.

These Subdivision Restrictions for Suneagle Bay Subdivision were originally filed for record in the Official Public Records of Real Property of Wood County, Texas.


