The Board of Directors and /or the Architectural Control Committee shall have the right to enter the property where violations exist under this paragraph and shall have the right to contract removal of such items and/or correct violations at the expense of the property owners and or the offending party.

WHEREAS, the property owners of lots in SunEagle Bay Subdivision are members of SunEagle Bay Owners Association and have the right and power to amend the subdivision restrictions and bylaws; and
