ARTICLES OF INCORPORATION

FOR

SUNEAGLE BAY OWNERS ASSOCIATION, INCORPORATED

Pursuant to the provisions of Article 4.03 of the Texas
Non-Profit Corporation Act, the undersigned corporation adopts the
following Articles of Amendment to its Articles of Incorporation which:

(a) limits the liability of the shareholders or members for monetary damages for an act or omission in the director's capacity as a director.

ARTICLE ONE.

The name of the Corporation is SUNEAGLE BAY OWNERS ASSOCIATION, INCORPORATED, Charter number 797338.

ARTICLE TWO.

The following amendments to the Articles of Incorporation were adopted by the corporation on July 17, 1993.

Article Seven of the Articles of Incorporation is hereby amended by adding thereto a new paragraph to read as follows:

The directors are not liable to the Corporation or its members for monetary damages for an act or omission in directors capacity as a director as set out in Senate Bill 260 of the 70th Legislature.

ARTICLE THREE.

The amendment was adopted in the following manner:

The amendment was adopted at a meeting of members held on July 17, 1993, at which a quorum was present, and the amendment received at least two-thirds of the votes which members present or represented by proxy at such meeting were entitled to cast.
