Crafts (optional Add-On) *Note each craft takes about 30 minutes and prices vary depending on material costs* Painting a Real Horseshoe (add \$10 per child)
T-shirt Decorating (add \$12 per child and provide sizes for all shirts at least 10 days in advance of your party OR add \$25 for this craft for up to 10 kids and \$2 for each additional child if you provide the shirts)
Paint a Canvas with your favorite farm animal. Kids go home with a 8x10 canvas painted by an animal of their choice. Canvas and paint put in Ziplock and then molasses put on outside of bag animal eats the molasses and designs an abstract painting at the same time. It gets messy but lots of fun. (Add \$6 per child)
Pinecone Bird Feeders (add \$25 for this craft for up to 10 kids and \$2 for each additional child. This is an activity and a craft. We will go look for pinecones in the woods and then decorate them with peanut butter and bird seed)
Painting Wooden Letters (add \$10 per child. We need 10 days' notice of which letter(s) yo will want)
Decorate a Wooden Frame with ink stamps and markers or paints (decoration materials are age appropriate and TBD)
Activities (optional Add-ons) *Note times for activities depend on party group size and are based on 10 children below*
Bobbing for Apples (add \$25. Note children will be wet and dirty. Towels are not provided so please consider bringing changes of clothes and consider temperature at the time of the event) Approx. 30 minutes.
Pinata (add \$65. We will fill it with basic candy and goodies or can load with your provided goodies. If you would like to bring your own filled pinata we have a place to hang it for the party game and this will only be a \$20 cost to hang and host the activity) Approx. 30 minutes
Paint the White Horse (add \$25. Older kids suggested but any can try! Our magical and very large white horse will be used as your canvas for your party background. This guy is friendly but feisty and fun to decorate.) Approx. 30 minutes
Nature Trail Walk and Donkey Sighting (add \$20. Walk through the wooded trails and find a few of the other donkeys and possibly a horse or two amongst the trees and the back areas. Find pinecones and/or branches for crafts and enjoy nature) Approx. 20 minutes
Wheel Barrel Race (add \$20. *kids 8 and older suggested* This will need to be done with kids strong enough to push each other in a wheel barrel) Approx. 25 minutes
Fire Pit and S'mores (add \$50. *kids 8 and older only*) Approx. 45 minutes

Birthday Party Guidelines Agreement

I agree to abide by all terms and conditions set forth in the Birthday Party Guidelines Agreement and that failure to adhere to these regulations will incur financial penalties and possible legal actions.

Please read this carefully and be aware that in signing up and participating in this program/activity, you will be expressly assuming the risk and legal liability and waiving and releasing all claims for injuries, damages or loss which you or your minor child/ward might sustain as a result of participating in any and all activities connected with and associated with this program. I recognize and acknowledge that there are certain risks of physical injury to participants in this program/activity, and I voluntarily agree to assume the full risk of any and all injuries, damages or loss, regardless of severity, that my minor child/ward or I may sustain as a result of said participation. I further agree to waive and relinquish all claims I or my minor child/ward may have (or accrue to me or my child/ward) as a result of participating in this program/activity against the farm including its officials, agents, program instructors, volunteers, and employees. I hereby authorize and give my consent to the district to photograph/video my child (or me), and without limitation, to use such photographs/video in connection with promoting/advertising the services, programs, without consideration of any kind. I have read and fully understand the above important information, warning of risk, assumption of risk, waiver and release of all claims, and photo/video authorization. If registering online or via email, my online signature shall substitute for and have the same legal effect as an original form signature.

DEPOSIT & PAYMENT

- 50% non-refundable deposit is required to secure the reservation. If you need to reschedule, we will try our best to work with you to find an alternate date/time. If you are unable to reschedule or accept credit toward a future party, you agree to forfeit your deposit. Rescheduling must be done 14 days in advance to retain a full credit unless we can book another event at your cancelled time.
- Remaining 50% plus add-ons, options and extra guests shall be paid upon arrival for event on day of party. Cash or check preferred. Credit cards can be processed but will incur an additional 3.5% credit card fee. Note all taxes, fees, and add ons will be collected before party begins on day of event or sooner.
- Please advise your guests and their parents to review the Equine Release /Waiver located at the bottom of every page on our website and attached to this form. Please make every effort to have all guests sign waivers prior to attendance. All guests without fully executed waivers will be included in the waiver above and considered your "ward" for this event.
- Please be sure that the party area is cleaned up, garbage is placed in the garbage cans and that the area is vacated by guests at the conclusion of the event. A \$50 fee will be added if decorations are left and/or trash is not placed in the trash cans before departure.
- Birthday parties are held at covered area off barn close to the petting zoo and riding area unless another request is made. When inclement weather, party can be held in barn or pavilion.
- Each party reservation includes a 15-minute set-up and 15-minute clean-up time. Your party hostess will assist with this.
- Items including decorations or other event materials may not be left after your event.

RIPTIDE STABLES EQUINE RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT

"Equine" means a horse, pony, mule, donkey, or hinny.

"Inherent risks of equine activities" means those dangers or conditions that are an integral part of engaging in an equine activity, including any of the following:

- a. The possibility of an equine behaving in ways that may result in injury, harm, or death t persons on or around them.
- b. The unpredictability of an equine's reaction to such things as sounds, sudden movement, unfamiliar objects, persons, or other animals.

"Participant" means any person, whether amateur or professional, who engages in an equine activity, whether or not a fee is paid to participate in the equine activity.

By signing this Equine Release and Waiver of Liability, Assumption of Risk, and Indemnity Agreement (Release), I represent that I have read this agreement and that I fully understand agreement. These Equine activities involve the risk of serious bodily injury including but not limited to permanent disability, paralysis and even death. I represent that I am in good health and in proper physical condition to participate in these activities. I understand the nature and risk of participating in Equine activities. I understand that this release is intended to include all activities whether on or off the equine.
