



## TERMS & CONDITIONS

### MEDICAL WAIVER

I, the undersigned (Parent/Legal Guardian), attest that my child is physically fit to participate in strenuous athletic activity, and hereby release N1 Basketball (N1) from any and all responsibility for injury or illness to my child as a result of my child's participation in the N1 Basketball Spring AAU season. Thus, I release and hold harmless N1, St Rose of Lima, directors, coaches, any of its officers, independent contractors, or affiliates associated with this program from any and all liability, both joint and several, arising from or in connection with my child's participation. I hereby authorize the directors of N1 to act on my behalf according to their best judgment in an emergency requiring medical attention. I understand that I am solely responsible for the payment of said medical expenses and must provide N1 with proof of medical/accident insurance.

### COVID QUARANTINE POLICY

**PRIMARY EXPOSURE:** If your athlete has been exposed as a primary contact to COVID and have developed symptoms, you must notify the Coach and N1. A quarantine period of 14 days must be served from point of notice. If your athlete has been exposed and does NOT develop symptoms, recommendation is to get tested after 3-5 days of initial exposure. If results return negative, can resume participation within 7 days of exposure. If No test is to be taken, athlete must quarantine for 14 days.

**SECONDARY EXPOSURE:** If your athlete has been exposed as a secondary contact to COVID and have developed symptoms, you must notify the Coach and N1. A quarantine period of 14 days must be served from point of notice. If your athlete has been exposed and does NOT develop symptoms, recommendation is to get tested after 3-5 days of initial exposure. If results return negative, can resume participation within 7 days of exposure. If No test is to be taken, athlete must quarantine for 10 days.

**VACCINATION:** If your athlete has been vaccinated, it is difficult to determine how contagious you can be. Recommendation is to get tested after 3-5 days of initial exposure. If results return negative, can resume participation immediately.

For the safety and security of all athletes within N1, recommend good judgement and common sense. *When in doubt, sit out.*

### LIABILITY WAIVER

I, the parent/guardian of this player, hereby give my approval for any and all basketball activities during the current season. I assume all risks and hazards incidental to such participation, including transportation to and from all activities. I hereby waive, release, absolve and indemnify and agree to hold harmless the N1, and any teams, organizers, sponsors, supervisors, participants and persons transporting my child, except to any extent covered by accident liability insurance.

### PERSONAL SAFETY

NJ Law requires that all *eyeglasses* worn during a sporting event be equipped with glasses having safety or shatterproof lenses. Metal frames are not to be worn during any basketball activities including games, practices, clinics, and camps. I confirm that any eyeglasses worn by my child are compliant with the law. I hereby waive, release, absolve and indemnify and agree to hold harmless N1, and any teams, organizers, sponsors, supervisors, officials, and participants for any damages caused by non-compliant eyewear. I understand that damages to eyeglasses are not covered by this organization's accidental liability insurance.

Any player having *braces* is required to wear a mouth guard during all basketball activities including games, practices, clinics, and camps. I hereby waive, release, absolve and indemnify and agree to hold harmless N1, and any teams, organizers, sponsors, supervisors, officials, and participants for any damages caused by failure to comply with this safety requirement. I understand that damages to braces are not covered by this organization's accidental liability insurance. No Jewelry to be worn during practices or games as we are not responsible for losses or damages.

### SUSPENSION POLICY

Suspension of a player will result if he/she displays: poor conduct, excessive foul language, has repeatable lateness/absence, or does not complete payment within a reasonable time frame. Duration will be determine based upon Coach and N1 directors review of each individual situation.

### SOCIAL MEDIA

I thereby, authorized N1 to use my child's image (Photograph and or Video) for use in N1's publications including, but not limited to videos, email blast, brochures, newsletter, website, social media any other form of print/electronic media, etc. I hereby, waive any rights to royalties or other compensation arising from or related to.
