The candidate information must be contained on a single one-sided 8½”X11” page and must be submitted in person by hand, or by mail, fax or e-mail, to the Association at the address indicated below by no later than **5:00 P.M.** on **November 1, 2019**, which date is 35 days prior to the date of the scheduled election.
