Mission Statement

Organized in 1983 to educate and encourage members in the quilting arts; to encourage high standards in color, design, and construction of the quilted medium; and to stimulate interest in quilting in the community.

General Policies

Guild Meetings are held on the first Tuesday of each month at 1 p.m. and 7 p.m. at the First Congregational Church, 2201 7th Avenue, Moline, IL. Guests are always welcome. After two visits, guests are requested to become Guild members. A nominal fee is charged to guests for meetings with outside speakers. Due to parking limitations, we ask that you carpool if possible.

Membership is open to anyone interested in quilts and quilting. Dues are \$35 per year payable in August or September. For new members joining after March 1st, dues are \$17.50. Student membership, intended for high school and full time college students, is \$17.50 per year.

The Guild year runs from September 1st to August 31st. Election of officers is held at the August meeting and inductions are held at the September combined meeting.

Board Meetings are usually held the second Tuesday of the month at 6:00 p.m. Any changes will be noted on the Guild Calendar and announced at General Meetings. Guild members are welcome to attend. Please notify one of the Board members if you plan to attend a board meeting to ensure that sufficient seating is made available.



Saturday Workshops: Topics, dates, and locations of Saturday Workshops will be announced in the Newsletter and at the monthly Guild Meetings.

Workshop Supplies and Basic Sewing Kit

General ideas to include in your basic sewing kit. Supplies may vary according to individual workshop requirements.

Needles, straight pins, threads to match, required fabrics, thimble, seam ripper, fabric marker (for both light and dark fabrics), scissors, and a bag or other container for scraps. Also, note paper, portable light source, and an extension cord are handy to include.

If a sewing machine is required for the class, be sure you are familiar with how to operate it. It should be in good working order (cleaned and oiled). Fill extra bobbins and insert a new needle ahead of time. Bring extra bobbins, needles, your owner's manual and a cleaning brush to class.

Arrive soon enough before the beginning of the class so you can set up and the class can begin promptly. Be sure to wear your name-tag! If an all day class is scheduled, bring your lunch and beverage.

General Guild Information

ANNOUNCEMENTS: Learn what is happening at monthly meetings. Submit your announcement to the President at least 24 hours prior to the meeting.

CHALLENGES: The yearly Guild Challenge is set up as a challenge for members. The guidelines may be specific fabrics or designs that must be incorporated into the finished project. Completed projects are hung and judged by Guild members at the September Joint Meeting. An entry fee may be charged and prizes awarded. There is also a **Quilt Show Challenge** using a theme and due at the upcoming Quilt Show. Occasionally, members will submit a Challenge for the membership. The Guild President must be contacted before any announcement of these challenges are made.

CHARITABLE PROJECTS: Throughout the year, we work on projects to donate to various charities. Bed quilts and baby quilts are given as the need arises to various organizations and families throughout the Quad Cities area.

FYI Board: The information here includes announcements and information about contests, other guilds' classes, shows, local shop sales, and any other notices of interest to our members.

HISTORICAL INTEREST: This committee will help you identify quilt patterns, fabrics., etc., and assist you in getting quilt appraisals by certified appraisers.

LIBRARY: The library is available only to members. Books, patterns, DVD's, etc., are available for loan. Members may be asked to show their current membership card when checking out materials. Overdue or lost material will be assessed a fee. Members with overdue material must return them (and pay any applicable fines) before they may check out any more materials.

NAME-TAGS: Guild members are asked to wear handmade name-tags to Guild functions and workshops. Please make your name-tag large enough to read from a distance. To win the monthly drawing, members must be wearing their name-tags.

NATIONAL TEACHER: Recognized national teachers are brought into lecture and/or teach classes. Fees are shared by class members. Guild members have first preference for classes. Non-members are asked to pay an additional fee. Class sizes are limited and paid reservations are required. Class fees are non-refundable. If you need to cancel, you must find someone to take your place unless there is a waiting list.

DOLL QUILTS: Throughout the year, guild members make doll quilts (approximate size: 24" x 24") that are given to Head Start students throughout the Quad Cities in December.

NEWSLETTER: Read the monthly publication for current information about Guild activities. Information for the Newsletter is due to the editor by the Friday following the Board meeting and should be neatly prepared or typed. Your name and phone number should be included. Contact newsletter@MVQG.org for rates for classified ads.

COMMUNITY EDUCATION: Various aspects of quilting are promoted throughout our community at exhibits, demonstrations, schools and appropriate events. Guild members are invited to volunteer to help at these events.

QUILT SHOW: Our main fund raiser is our biennial Great River Quilt Show. The show promotes quilting, helps fund Guild functions, speakers for meetings, etc., as well as our charitable contributions. We make a raffle quilt and host a merchants mall. Guild members display their quilt art. (see Quilt Show Eligibility Rules on Page 6).

SKILL BUILDER: Guild members teach half or whole day classes on a special skill or project. The charge is \$15.00/member for a full day class and \$10/member for a half day class; plus materials. Class fees should be paid when registering. Fees are nonrefundable. If you need to cancel, you must find some one to take your place unless there is a waiting list.

SHOW AND TELL: Be motivated to quilt and motivate others by showing quilts and quilt related items to members each month. Please give your name and a short comment, and pick up a pin to attach to your name tag.

DOOHICKEY DRAWING: An Americanism dating from 1910-1915; a doohickey is a gadget, a dingus, a thingumabob; a nifty quilting tool that a quilter may want, has never heard of or is too expensive to purchase. Each month a new Doohickey is offered to our membership. The doohickey may be a new "cool" tool or it may be something tried and true. It may be expensive or not so much. This drawing is intended to be self-sufficient so the next month's prize will be determined by the number of tickets sold the previous month. Tickets will be sold at the afternoon and evening meetings. The winning ticket will be drawn at the end of the evening meeting..

STITCHING GROUPS: We have several groups that meet at various locations. Check the Newsletter calendar for times and locations.

WEBSITE: The Guild maintains a website: www.mvqg.org to help advertise our Guild and share information with our Guild members. If you wish to have items posted to our site, please contact the webmaster.

QUILT SHOW ELIGIBILITY RULES

- Only members of the MVQG can enter a quilt into the Quilt Show; judging is optional.
- To enter a quilt, the entrant must be a member in good standing of the MVQG the year of the show and the previous year (due to registration deadlines).
- To enter a quilt in the show, the entrant must have participated in the construction of the quilt, e.g., piecing, applique, or quilting.
- In a duet category, only members will be eligible to receive a ribbon. Winners in a non-duet category receive one category ribbon.
- Special exhibits, e.g., Gravel Road, River, Q of V, not judged but entered under one member's name can include quilts from non-members. The quilt show committee determines what special exhibits will be included in each show.

Basic Quilt Classes are occasionally offered by Guild members. Also, we encourage you to take a class from one of the quilt shops listed with an "S" in the Membership Booklet or from one of the many teachers listed with a "T".

Members who are willing to quilt for others are indicated with "Q/H" for hand quilting and "Q/M" for machine quilting, also used is "LA" for long arm machine quilting, "B" for binding, and "Q/B" for quilt basting, "R" is for quilt restorations.

"L" indicates members who are willing to give lectures.
