

RANGE RULES AND REGULATIONS FOR HIGHTECHREDNECK'S, LLC. INDOOR SHOOTING FACILITY

Hightechredneck's, LLC is a private, members only facility. You must prove basic pistol competency and a sufficient knowledge of pistol/range rules to qualify for a membership card. This members card must be presented at each range session. No exceptions. Hightechredneck's, LLC, and it's representatives, reserves the right to refuse/revoke membership.

Membership.

Initial membership is \$1.00 dollar (one dollar). All members must watch a safety power point presentation, do a range orientation w/ the range officer, rent 30 minutes of range time, and shoot a designated number of rounds for the range officer to determine your ability to control your firearm. Once these conditions have been met, the range officer will issue a membership card. Effective 6/11/2014, all members must stay **6 MONTHS CURRENT**. What that means is, if you haven't visited the range in the last six months, your membership will lapse and you will have to pay a \$20 reinstatement fee to continue to use the range. This is to ensure member participation in the organization and maintains a current level of proficiency and safety. Membership cards will be marked w/ a specific stamp and dated to ensure compliance.

GUNS & TARGETS BROUGHT INTO THE RANGE:

All firearms brought into the range must be completely UNLOADED, or a valid CCW permit must be presented for any loaded firearms if you are a conceal carry permit holder. All guns and ammunition are subject to inspection by the range officer for cleanliness, workability and safety before entering the range. Targets may be brought into the range ONLY if approved by the Range Officer. Numerous targets are available for a reasonable price at the storefront.

RANGE OFFICER:

1. The Range Officer on duty is in direct charge of the range and all participants at all times.
2. The Range Officer will immediately address any shooter on the range handling a firearm in an unsafe or careless manner. **YOU MUST OBEY ALL COMMANDS FROM THE RANGE OFFICER.** Failure to obey his/her commands will result in permanent ejection from the facility and could result in criminal charges.

FIRING LINE PROCEDURE:

1. Only one loaded gun at a time. No unnecessary gun handling behind the firing line.
2. Make sure your hearing and eye protection are on *before* entering the range. Take position at the lane assigned to you. **Do not** change lanes.
3. The **MUZZLE MUST BE POINTED DOWN RANGE AT ALL TIMES AND HORIZONTAL TO THE FLOOR.**
4. Shooters must load and unload their own firearms. If a mechanical malfunction occurs, and you are unable to clear it, set the pistol on your lane table with the muzzle downrange, and consult with the Range Officer. **DO NOT REMOVE JAMMED OR MALFUNCTIONING FIREARMS** away from the lane.
5. Only line of sight firing is permitted. (**No drawing from the hip or holster.**) Keep your finger off the trigger until on target.
6. When leaving the firing line temporarily, lay the firearm with the muzzle down range and the action open.
7. Upon completion of shooting session, unload firearm(s) with the action opened, unless it is cased.
8. Cease Firing means...**STOP SHOOTING AND STEP BACK** from lane with your hands visible to all shooters.
9. Remember...**SAFETY FIRST, SAFETY LAST, SAFETY ALWAYS.**

VANDALISM:

Any person seen firing at lights, baffles, carriers or any other range property or equipment will be escorted from the property, no refund given, and will be reported to the proper authorities for appropriate action. All shooters will be held accountable and will pay for any damage you cause including replacement and installation charges. **DIGITAL VIDEO SURVEILLANCE AND RECORDING RUNS WHENEVER THERE IS A SHOOTER ON THE LINE.**

PERMISSABLE FIREARMS: 22 pistol through and including 45 auto/45 LC pistols. **Magnum firearms are not allowed (with the exception of 38 special in 357 pistols).** No rifles, black powder firearms, or explosive ordinance is permitted.

FIREARM RENTAL:

Firearms can be rented at Hightechredneck's, LLC at the advertised price. You must purchase ammo for that rental from Hightechredneck's, LLC. No returns of left over ammo. *****Due to a recent increase of range related suicides, first time (unestablished) customers who wish to rent a firearm, will need to be accompanied by another paying customer. No exceptions...don't ask.**

PERMISSABLE AMMUNITION:

1. Standard commercial and reloaded ammunition is permitted. +P ammo maximum. Ammo considered by the range officer to be exceeding allowable tolerances will be grounds for permanent ejection from our facility. If you're not sure, you need to ask.
2. Any ammunition that is not typically used for personal/home defense is **not permitted** and is grounds for permanent ejection from our facility.
4. **Tracer, incendiary, armor piercing, gas, birdshot, or explosive ammunition is not permitted and is grounds for permanent ejection from our facility. Hightechredneck's, LLC and it's representative, have to right to inspect all ammunition entering the facility.**
5. **ALL BI-METAL AND IMPORTED AMMO IS BANNED FROM THIS FACILITY.**
6. The EPA has mandated that all indoor shooting facilities should be using frangible or jacketed bullets. Hightechredneck's will comply with that mandate. No all lead rounds may be used at this facility. Bullets must have a jacket that encompasses 80% of the bullet (i.e., a jacketed soft point is permissible). We are compliant with this mandate to provide a safe shooting environment for our staff and customers.

FIRING LINE OCCUPANTS:

1. All persons using the facilities shall be of good character. Appropriate dress is required at all times. Hightechredneck's, LLC is a private/members only facility and we have the right to refuse service to anyone. Persons smelling of alcohol on their breath or who appears impaired will be required to leave the facility. Inappropriate language, gestures, or innuendo will not be tolerated.
2. All persons utilizing the range are required to receive, understand and sign the rules, regulations and disclaimer and waiver of liability notice.
3. A responsible paying adult must accompany persons under twenty-one (21) years of age. This adult shall act as a coach, and **MUST** remain with the minor(s) at all times while the minor(s) utilizes the range.
4. **NO FOOD, DRINK, CHEWING TOBACCO, SNUFF OR SMOKING ALLOWED ON THE RANGE or in the storefront.**
5. Only one shooter and coach permitted per firing lane; only one un-cased firearm permitted at the firing lane.
6. Persons not shooting or coaching are not permitted on the range.
7. No one is permitted forward of the firing line. (NO EXCEPTION)
8. Any equipment or other personal items in/on a shooting lane left unattended are at the owner's risk. Hightechredneck's, LLC is not responsible for lost or stolen items.

BRASS RETRIEVAL:

1. All range brass that falls forward of the shooting bay is the property of Hightechredneck's, LLC.
2. Do not enter the range area in any way to retrieve brass. This includes reaching forward of the enclosed shooting area. Violation of this rule means immediate and permanent ejection from our facility.
3. Receptacles are in place for the trash and brass. Please leave your shooting bay as you found it. Place trash and brass in the appropriate receptacles. 22 LR brass and aluminum or steel cases should be disposed of in the regular trash. Brass in the brass receptacle is the property of Hightechredneck's, LLC. Any failure to fire rounds may be left with the Range officer for proper disposal.

EYE/HEARING PROTECTION: 1. Safety glasses and NRR 30 hearing protection are MANDATORY when entering the range. Hightechredneck's, LLC rents both for a nominal fee or you may purchase from our inventory.

PLEASE ASK THE RANGE OFFICER ABOUT ANYTHING YOU ARE NOT SURE OF. WE ARE HAPPY TO HELP IN ANYWAY WE CAN.

HELP US KEEP THIS RANGE SAFE. PLEASE ABIDE BY THE RULES AND REPORT TO THE RANGE OFFICER ANYONE YOU SEE NOT OBEYING THE RULES: AFTER ALL, IT'S YOUR SAFETY WE ARE CONCERNED ABOUT.
