This release is for any and all liability for personal injuries (including death) and property losses or damage occasioned by, or in connection with any activity or accommodations on Hightechredneck's, LLC property. The undersigned further agrees to abide by all rules and regulations of Hightechredneck's, LLC and agrees to pay for any and all damages caused by their firearms, ammunition, vehicle or self and/or guests. I further understand that shooting can be dangerous and will at all times exercise safe gun handling practices. I agree to indemnify Hightechredneck's, LLC from and against any and all manner of claims, demands, damages, losses, liabilities, costs or expenses of any nature or kind whatsoever, including attorney fees and court costs, which may now or hereafter be sustained, suffered or incurred by Hightechredneck's, LLC as a result or any claims asserted by me or by any other member or guest as a result of my participation at Hightechredneck's, LLC.

\*\*\* For anyone between the ages of 16 and 21 years of age (Ohio law considers 18 to 21 a minor status for pistol ownership/use purposes), Hightechredneck's, LLC Range Liability Statement for A Minor MUST be signed by a parent or legal guardian who is present to accompany the minor while shooting. I have fully read, understand and agree to abide by the range rules, regulations and waiver of liability consisting of four (4) pages.
