Dogs To Be Trained

Only retriever breeds can be trained on club grounds. Each dog trained on club grounds MUST be supported by the owner's club membership.

TRAINING ON CLUB GROUNDS

- Only paid club members will be allowed to train on the property.
- Members shall be respectful of others when training. Tests shall be set up so as not to interfere.
- Grounds are open to Pro training Monday thru Thursday each week with no time limitations. This consideration only applies to our current field trial Pro's Jim Beck and Steve Blythe. This does not exclude any other club member from training on these days. Pro's may not train client dogs on Memorial Day, July 4th or Labor Day.
- In addition, members that train for Hunt Tests are being asked by the BOD to use the SW corner of the property as their primary location.
- Should the main grounds not be in use by 6:00 pm, all areas in the evening will be open to train on a first come, first-serve basis.

GROUND UPKEEP

Avoid excess driving on wet, soft grounds. Members shall pick up & dispose of all their litter, cans, shell casings, etc.

GATES

All gates must be closed and locked by the last person leaving the club grounds. Gate combinations are for club members ONLY.

ACCIDENTS:

The Sioux Valley Retriever Club will not be liable for personal injuries that may occur on club property or other properties that are being used for club sponsored events.
