**4. NOT TO HAVE FILINGS DESTROYED.**

**5. NOT TO HAVE FALSE ENTIRES UPON FILINGS.**

**6. NOT TO HAVE FILINGS NEEDLESSLY DELAYED UPON MY CASES WITHOUT JUST CAUSE.**

**7. A COURT THAT IS WITHOUT BIAS OR PREJUDICE AND ENSURES LITIGATION EQUALITY AND RESPECT FOR ALL LITIGANTS, PARTICULARLY FOR PRO SES WHOM ARE CONSIDERED INCOMPETENT, DUMB AND ROUTINELY RECEIVE NONE.**

**8. A COURT THAT IS COMPRISED OF JUDGES WHOM CONSIDER THEMSELVES TO BE COMPETENT AND OF SOUND MIND.**

( JUDGES WHOM CONSIDER THEMSELVES MONSTERS AND AN OXYMORON TO THEIR TITLE OF JUDGE SUCH AS RAMON E . REYES DOES WITH HIS EMAILS OF THE MONESTER OF WHICH HIS EXACT EMAILS ARE ON US COURT CORRUPTION.ORG IS APPARENTLY NOT OF SOUND MIND TO BE A JUDGE. )

AMENDMENT I

Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or **the right of the people peaceably to assemble, and to petition the Government for a redress of grievances.**

AMENDMENT XIV - Passed by Congress June 13, 1866. Ratified July 9, 1868.

Note: Article I, section 2, of the Constitution was modified by section 2 of the 14th amendment.

Section 1.

All persons born or naturalized in the United States, and subject to the jurisdiction thereof, are citizens of the United States and of the State wherein they reside. No State shall make or enforce any law which shall abridge **the privileges or immunities of citizens of the United States; nor shall any State deprive any person of life, liberty, or property, without due process of law; nor deny to any person within its jurisdiction the equal protection of the laws.**

SUCH MATTERS CANNOT BE HANDLED BY JUDGES WHOM ARE INCOMPETENT IN PRACTICE AND IN MENTAL FITNESS TO DO SO. JUDGES WHOM CONSIDER THEMSELVES MONSTERS ARE UNFORUNATELY..... NOT ACCEPTABLE WHATSOEVER.**

**FOR FEDERAL SERVICE TO BE ORDERED BY A CERTAIN DATE UPON DEFENDANTS AND SUCH DEFENDANTS TRY TO PUT THE PLAINTIFF IN JAIL FOR DOING SO, IT IS NOT OPTIONAL FOR THE JUDGE TO SIT BACK AND DO NOTHING ABOUT A LITIGANT WHOM ABIDES BY COURT ORDERS AND JAILED BY DEFENDANTS FOR DOING SO.**
