Now, within a matter of two hours of when that was uploaded, I put forth corrected documents and stated that that was an erroneous upload and the corrected documents were uploaded to the clerks within only two hours. That document was not intended to be given to the judge or any judge, and the clerks did it intentionally and deleted the filings that were not erroneous. I provided the corrected filings and a letter regarding that being an erroneous filing. What happened to it?

Now, this is not the only time the clerks have destroyed what I have filed. Or someone did. Did the judges destroy it? Did you destroy it? Who destroyed it? Because I uploaded them. I just want to make it clear at this time that we have ... if you want to talk about any type of hate speech or malice, the clerks put forth, gave to the judge, apparently, a filing with malicious intent because that was never to be given to the judge and I informed them of that and I put forth corrected documents, stated that was erroneous within only 120 minutes. You know that if I upload anything to that portal, how long does it take to get onto Baser? A week? Two weeks? Within only 120 minutes, the corrected copies were placed there and the judge writes an order regarding copies that were never to be presented to make me look bad.

That's malicious. That's malicious on the part of the clerks to do that. Or if the judge knew about it and if the judge did it or the judge is part of it, I don't know who did it. Someone did it. This is, once again, what I file gets destroyed and gets lied upon and misconstrued because that was never to be ordered upon. That was erroneous and that was corrected and the proper ones were uploaded. I want to make that clear and I hope the judge hears this. Like I said, if there's a real judge there. I've never seen the judge. I don't know who works there. I litigate before a picture, as crazy as that is. Maybe you, the clerk, is the ... I don't know.

I don't know who's running the show, but I know what I did and I know what the truth is and I think it's very disturbing that an order comes down that is absolutely a fraud to the facts of this matter, that that filing right there was erroneous and it was corrected and was improper to be given to the judge and the proper documents provided and they did not provide the proper documents. I made very clear that was what I just filed before was ... not filed, what I uploaded before was erroneous and these are the correct

ones. Never got filed, just uploaded and I made it clear that that was an error on my behalf. I want to make this very clear. I'm asking the judge that the record reflect that, that he write a new order in regards to the truth and I'm tired of my documents that I file to the court to be destroyed.
