



Rider Pass Agreement

To buy an open riding pass, you are required to complete this Rider Pass Agreement and sign the Facility Rules and General Liability Release forms. You must also provide your state photo ID, truck & trailer information, & proof of yearly vaccinations on EVERY horse you bring to the facility.

Rider Pass Instructions:

1. **Pass:** All visiting riders must wear their pass visibly on their person, at all times, on Scotsman Center Property. It will visibly note your name, pass expiration date, and emergency information.
2. **Replacement:** If you lose your pass, a \$10 fee will be required to replace it. Please notify us immediately if your pass is damaged or has incorrect or outdated information—we will replace those passes for free.
3. **Access:** Park your trailers in the North East parking lot, taking care not to block either garage door or chain link entrances. To access the arena, enter the equine area through the northern chain link “man” gate (the lock code will be given to you by our staff). Please remember to close gaits behind you and re-lock them when you leave. Riding passes are valid for use of round pen, indoor, and outdoor riding arenas only—DO NOT enter the feed or storage areas unless you have a lease contract. Riding passes only valid during operational hours 8am-8pm, and are not valid during scheduled events. Rider pass users may not adjust or operate heaters, sprinklers, arena drag, or P/A system unless given permission.
4. **Biosecurity:** All horses brought onto Scotsman Center property MUST have proof of yearly vaccinations for at least Eastern & Western Equine Encephalomyelitis, Tetanus, Influenza type A2, and Rhinopneumonitis EHV-1 & EHV-4. For biosecurity purposes, please do not allow your non-boarding horses to touch noses to or otherwise interact with our boarding horses.
5. **Ride areas:** You may ride on designated equestrian areas. You are welcome to enter the office building to use bathrooms and the lounge areas—the payment drop box is by the front office. Please do not enter any storage areas, namely the north warehouse, the hay area, or tack lockers. See attached map.
6. **Ride Times:** Open riding pass hours are determined by management and are subject to change at any time during the duration of your riding pass.
7. **Pass types:** Family passes are good for up to 4 people. If your child can independently ride a horse, they need their own pass or should be included as one of the 4 on the family pass. Seasonal passes: October 1st – March 31st and April 1st – September 30th. Month passes are calendar month to month (ex/ March 1 to 31).
8. **Paperwork:** All riders need to read and comply with the Facility Rules Form! Even Day Pass riders MUST complete all associated paperwork, as outlined in the Facility Rules. Put paperwork and payments in the drop box by Management’s office.

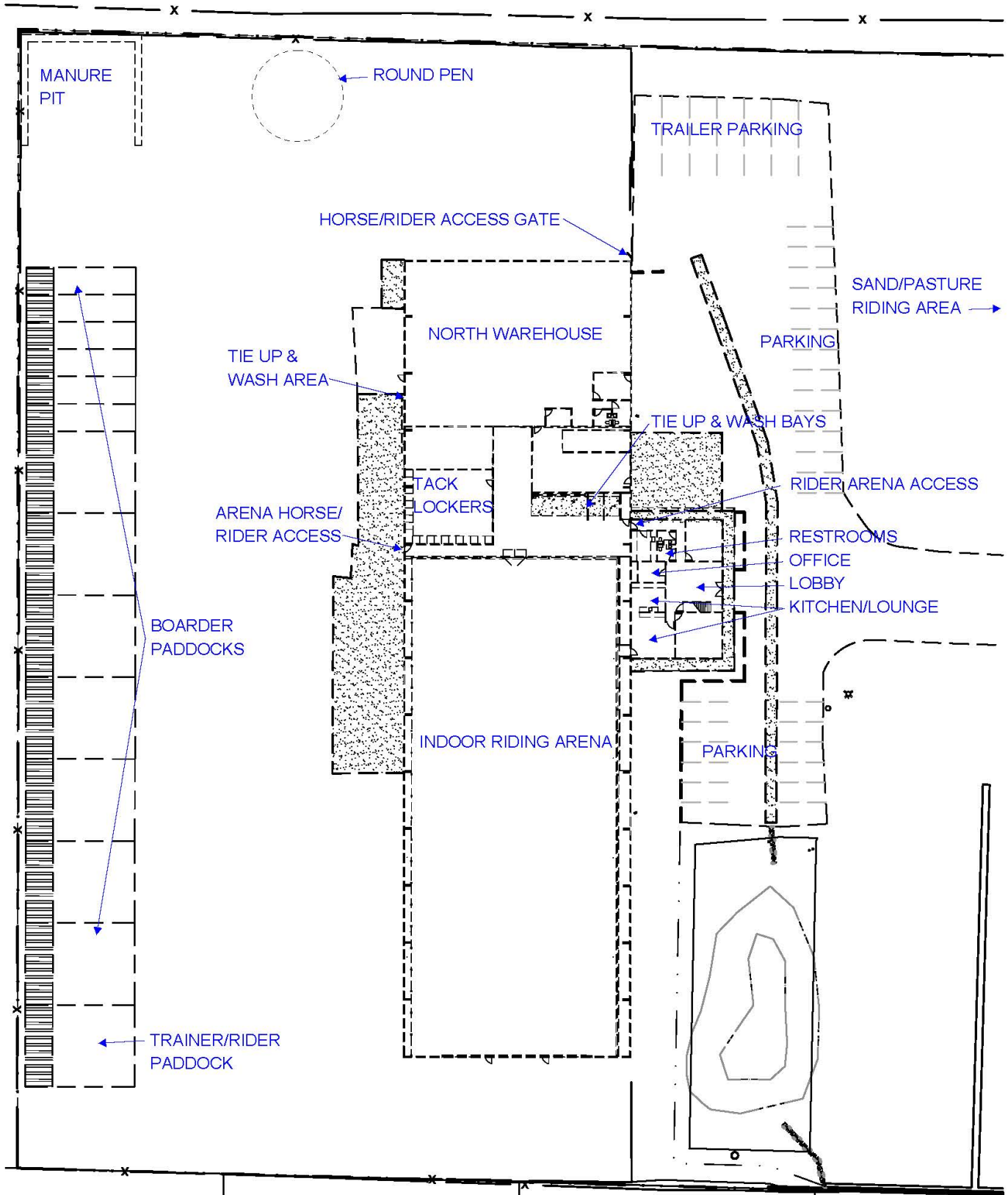
