### Mayor: INGORPORATED 1833

A couple of months ago we have approved two new road names for the Winterton Condominium President Way and Hooper Ct, after the Site Plan Amendment just approved by our ZBA the owner removed Hooper Ct Road and to remove it from the 911 system the county asks for a revised BOT resolution that remove Hooper Ct.
