- 1. Bylaws revision review and action needed AAYC-Bylaws-CNPL 2023 01 22.doc
 - a. Bylaws were last updated in 2020. We just received the new bylaw, and there isn't enough time to review before the annual meeting. The board noticed multiple errors for the bylaws, and parts of the bylaws aren't finished. Val suggested that the Board take the time to review the bylaws, and vote as a board at a later meeting. The attorneys said we were missing parts of the bylaws that are required by law.
 - b. There was some discussion about whether a member vote was needed to amend the bylaws.
 - c. Val suggested that the one change to the bylaws we vote on at the annual meeting would be to call for an amendment to the bylaws change article

6 so that we can further amend the bylaws at a later date, after time for review, by electronically or by mail

Board action: Holli motions to amend article 6 in the bylaws (contingent on lawyers approval) and be presented to the membership at the annual meeting. Beth seconded. Motion passes

ARTICLE VI. AMENDMENTS

Proposals for amendments or additions to these Bylaws must be submitted in writing to the Board of Directors at a regular meeting of the Board and must be presented either by an elected Director or as signed by twenty-five percent (25%) of the members. The proposal shall be read at the meeting and copies shall be distributed, at which time they shall be voted on. The Amendment shall then be presented to the members at the next annual meeting, at for vote electronically or by mail, after which time the amended Bylaws shall take effect. No Amendment or addition of these Bylaws shall be made which is not in harmony with the Alliances purposes.
