### **OLD BUSINESS**

 Skill Rated Play/DUPR Round Robins – It was clarified by Bill Schlimgen that the DUPR participants will reserve their own courts. Blocking "Hold My Court" is not required.

#### **NEW BUSINESS**

- Skill Rated Play/MLP Proposal A proposal to allow MLP/Skilled Play, courts 1 through 6, for 2 hours on Saturday, for the duration of seven weeks was altered by Julia to allow the same amount of playing time utilizing only 4 courts at the most. Example: Courts 1 & 2 would be blocked from 1-5 pm and Courts 3 & 4 would be blocked from 1:00 3:00 pm. This will take place once a week on Saturday afternoons for a duration of seven weeks. The discussion was led by Jack Wilkerson with comments by Michelle Taylor, Bill Schlimgen, Connie Scovin, Kim Cunningham and Cindy Tiedeman. Vote ensued with 31 YAY, 11 NAY, 14 Abstained.
- 2. Open Play The Board met with Julia Holland (CM HOA Director) to propose reduction of Open Play Court usage from 6 courts to only 2 courts per day on Courts 5 & 6. She agreed, so the Board presented it to the membership. Discussion ensued with comments from Lori Frazier, Lou Brentzel, Pat Henry. President Dale Sargent stated to the membership, that this proposal was what the membership wanted, not something the Board came up with. Continued discussion with Polly Mann, Dana Browning, Bill Scovin, Barb Wilcox, Edna Vasquez, Cindy Tiedeman.

Based on the feedback from the discussion, the proposal was altered to favor more Open Play Courts. The new proposal agreed upon was to reduce from 6 courts to 4 courts on Courts 1-4. No Novice Court. Courts 5-6 will be available to reserve on "Hold My Court". Open play time will be the same. A vote ensued and was overwhelmingly passed.

**ADJOURNMENT**: A motion to adjourn the meeting was made by Bill Schlimgen, seconded by Ritch Fuhrer. The motion was unanimously passed. The meeting was adjourned at 7:10 pm.
