



CantaMia Pickleball Club Rules

November 1, 2016

Revised April 10, 2020

Purpose: The following rules and guidelines are meant to assist the purpose of the CantaMia Pickleball Club (CMPC), which is to provide a fun, healthy, recreation activity for all CMPC members.

Hours of Play: The courts are open from 6:00am to 9:00pm daily. (The HOA abides by a combination of the City of Goodyear lighting and noise Ordinance and the Village Center hours of operation.) It is the responsibility of the last group using the lighted courts to turn off the lights prior to leaving the courts.

Court Schedule: CMPC sanctioned activities have priority use of all courts for club activities, events and tournaments. Courts may be scheduled at other times by all CantaMia community members via holdmycourt.com by accessing cmpickleball.com or cantamiaestrella.net.

Court Rules:

- Water only, in closed containers, are permitted. Sports drinks and other beverages may be consumed outside of the court area
- No food permitted on courts
- Wipe debris off shoes before entering the courts
- Only non-marking outdoor court shoes are permitted on the courts
- Proper court attire is required
- Eye protection is recommended
- Only community furnished chairs and benches are permitted on the courts
- No animals permitted on the courts
- No alcoholic beverages permitted on the courts
- No smoking permitted on or around the courts

Visitors and Guests: As members of CMPC, we are to follow the CantaMia HOA guidelines regarding visitors and guests. All guests under 18 are not permitted to use the fitness room, aerobics studio, steam & sauna rooms, indoor & outdoor spa, spa treatment rooms, indoor lap pool, billiards area & bocce/pickleball/tennis courts. All guests age 18 and older using CantaMia facilities, including the pickleball courts, are required to register at the Village Center, on each visit, to pay the daily fee and ensure a signed waiver is on file.

Trash: Keep the courts free of trash and debris. Check the court when you have completed play. Trash cans are provided outside of the courts for your empty water bottles, etc.

Court Conduct: Good sportsmanship should always be adhered, as well as, refraining from the use of bad/foul language. All players are expected to abide by the CantaMia HOA Code of conduct and USAPA.

Equipment: Only regulation paddles, pickleballs, training equipment are permitted on the courts. Unauthorized chairs, rollerblades, skates, skateboards, bikes, etc. are prohibited.

Membership: All CantaMia residents (owners, renters, spouses) are eligible for full membership in CMPC. Full club membership is required to participate in CMPC activities and events. This includes paid yearly dues (October 1-September 30), a completed renewal/new member form and signed waiver on file with club Treasurer.

Liability waivers: All CMPC members and participants in tournaments are required to sign the CantaMia at Estrella Community Associations, Inc., Waiver and Release of Liability prior to any CMPC activity.

Injury and Incidents: A simple First Aid kit is located inside of the storage area at the amenity area bocce courts. Any injury resulting in a call to 9-1-1, the address is 17700 W Starpoint Dr., Goodyear. Contact the CM Guardhouse and contact the Village Center staff. Post someone at the entrance into the Village Center off CantaMia Pkwy to direct EMS to the proper area. In the event of a HEAD INJURY, do not move the patient nor place anything under their head but keep head in proper aligned placement. The patient should not be given anything to eat or drink. **AED:** An Automated Electronic Defibrillator (AED) is located outside on the wall next to the men's restroom at the amenity area. Turn POWER ON first, and the AED will guide you through the steps.
