PART - 1: Service Agreement, Guidelines and State of Florida Law, Hold Harmless

I, _____ acknowledge that I am the owner, lessor, agent/designee and/or authorized representative of the aforementioned real property, I hereby certify that **I95 Towing & Transport** "illegal park" and/or "unauthorized vehicle" signs will be posted in accordance with **Florida State Statute 715.07**. This agreement shall terminate upon written notification from either property representative or the towing service. Also, this is a 1-year agreement & shall renew automatically every 365 days.

I understand that one of the persons ("authorized associates") listed below in this agreement must be present at the time of tow in order to verify any and all vehicle(s) to be removed from said real property, as well as sign the work invoice presented by the responding tow operator(s) employed by **I95 Towing & Transport**. Furthermore, I understand that I and/or my "authorized associates" may substitute the signing of the work invoice by completing and signing an "Express Consent" form that is to be subsequently faxed/E-Mailed to the office of **I95 Towing & Transport** prior to the service request, as allowed by and/or in compliance with the chapters 713 & 715 of the Florida State Statutes of record. When a person improperly causes a vehicle or vessel to be removed, such person shall be liable to the owner or lessee of the vehicle or vessel for the cost of removal, transportation & storage; any damages resulting from the removal, transportation, or storage of the vehicle or vessel; attorney's fees; and court costs.

Trespass towing shall be authorized 24 hours a day, 7 days a week. Requests to skip or excuse any vehicle(s) shall be called in or emailed to us to our contact info above. Any & all vehicles towed will be towed to a fenced & secure lot. The parties within this agreement shall always be in compliance with the Florida Statutes Chapter 713 & 715.

My signature indicates my full knowledge and understanding of **PART-1** of this agreement, its meaning, purpose and execution. Furthermore, I hereby agree to hold **I95 Towing & Transport** harmless from loss or damage or any associated expense(s) from any and all claim(s) that may result and/or arise out of any motor vehicle(s) me or my "authorized associates" have requested to be removed from said real property and/or location.
