

MIFD Annual Meeting Nominating Committee Report  
 May 23, 2026

The MIFD Nominating Committee for 2026 included Kevin Riley and Kristin Foster from the MIFD Board, and as required by the Bylaws, three non-Board members, Gail Lane, Amy Estabrook and Tory Christian. The Nominating Committee nominates the following slate of Officers and Directors for the 2026-2027 fiscal year, commencing on July 1, 2026:

Three Board members terms expire at the end of June 2026: Scott Parry, Ethan Tower and Jeff Miceli. While Scott Parry retires as President, he has agreed to continue as a Director filling a one-year vacancy from Tom Giola’s term. The Board wishes to thank Jeff Miceli for three years of service, most notably for his work with the Mystic Fire Department and launching the emergency preparedness committee with MIPOA. The board also wishes to thank Tom Giloa for his two years working as Chair of the Facilities and Roads Committee and brainchild of the now installed roadside buried stone revetment along Chippechaug Trail at Allyn’s Alley. Ethan Tower has agreed to serve another three-year term as a Director and will resume the Facilities and Roads Committee Chair work Tom is vacating. Anne Navin has agreed to join the Board as the Vice President and will communicate with the Mystic Fire Chief as well as represent MIFD on the Emergency Preparedness Committee roles Jeff is vacating. Nancy Taylor Ross has agreed to assume the role of Treasurer. Bill Taylor has again agreed to take on the one-year term of Tax Collector for the 2026-2027 fiscal year.
