



Magic Pain Juice XS With CBD and CBN

Dr. MAK's Magic Pain Juice is a topical liniment for temporary relief of muscle and joint pain. This product contains a mixture of natural terpenes, sesquiterpenes, alcohols, herbal extracts and cannabinoids in a DMSO/2-propanol transdermal carrier, providing pain relief, muscle relaxants and increased blood flow to the area. The product is applied in liquid form to the affected body parts and provides up to 4 hours of relief per application.

Magic Pain Juice comes in a 25 mL (0.9 oz) roll-on bottle. Each bottle contains 1500 mg of CBD and 100 mg of CBN. Each bottle comes with a QR code that pulls up a product description, drug facts panel and the independent third-party laboratory analysis for that specific batch.

Shake the bottle well before use. Apply liberally to the affected area. Repeat as needed 3-4 times per day.
