Commissioners opinion on obtaining an extended 10 year lease contract with Pittsgrove Township on the 2 storage bays we currently use at the township garage Discussion followed. Need to submit a letter to Charlotte to request a 10 year lease for \$1. M Cousin S Schmidt to send a letter before replacing doors. AIF The Chief will look into additional quotes.

Commissioners opinion on replacing the garage doors at the township garage with automatic openers allowing easier and faster access to our equipment.

Price quote from Elmer Door on 10/30/24 Option 1 non insulated doors \$9,575 Option 2 insulated doors \$11,060 (Recommended)

Status of CDL Licensing for members M Mathews S Schmidt for up to three members, including Nash, to take the CDL course. AIF

Status of progress with New Fire Station

K. Myers and R. Smith met with the Superintendent of Pittsgrove Schools on October 16th to discuss a fire department connection to their irrigation system that would be available 24/7 365 days a year whether school is in session or not. A future meeting is going to be planned with the Maintenance Supervisor and a Representative of the irrigation company that installed the system.

The Chief is working with the school maintenance manager to develop a plan

Discussion on 2 programs the Fire Company would like to see approved by the Commission

- Firefighter Reimbursement Program Active and Jr. \$400 per year max payout for damaged items and mileage to runs and drills. 18 x 400 \$7200
- Firefighter Incentive Program Same eligibility as above, based on LOSAP percentages, max payout is \$599 for over 40%, below 40% will be proportional based on percentage ran. Schmidt ran the numbers, 18 FF's right now 9 are eligible for losap \$5391 if paid out today. \$8071.54 for this program. Roughly 18,000 total for the entire program as we stand right now. The finance committee will review and bring it back to the next meeting. The board will try to get the budget line established.
