The Chief requested the ok to start working up prices to replace the command vehicle. He intends to purchase the vehicle via state contract. The board was ok with moving forward on pricing.

#### **Company Report**

Kris said the hydrant was temporarily fixed but the switch still needs a permanent replacement.

#### **Old Business**

Chairman Smith brought up repairing the well. They requested quotes from three vendors but only one had responded. The quote was for \$17,384.00 and Rick said that Braslow ok'd the purchase due to three quotes being requested. Discussion followed.

Chairman Smith said he had a quote for replacing the property line trees from TBI landscaping. Discussion followed; the topic was tabled.

There was discussion about the future of the building. The board asked Myers Jr. to reach out to Garrison Architects to see if they would work with us on a long-term plan.

Chairman Smith said we still need to get the attic ladder installed. He will work on finding someone to install it for us.
