Mathews talked about potentially doing some driver training so members could attain a CDL. His contact says that it would normally cost \$4200 per person but they would be interested in doing a deal with us for \$2750 for a minimum of 4 people. Discussion followed.

Dave W asked about LOSAP, specifically asked for clarification on how the board makes changes to LOSAP. He also asked about how LOSAP removal works. Discussion followed.
