Old Business

Schmidt met with TRANE about the HVAC systems, there hasn't been anything back from them yet.

Nothing new from Braslow. The board will need to initiate a phone or video conversation with him since he refuses to reply to emails with anything except "call me".

New Business

Dave W said that he has some prices for repairing the scene lights on 23-6. The bulbs they use are no longer available, so the only viable option is to upgrade to LED lighting. The lowest quote so far is \$5739 for four lights and installation. On a motion by Mathews and a second by Schmidt he was approved to get them fixed pending two additional quotes are submitted. Vote: AIF

There was a conversation about adding a generic code to the alarm system for vendor usage. The board was good with the idea, someone needs to ask Nash to call the alarm company to add a code.

Schmidt said he's been working with a couple of vendors to repair the overhead door in front of 23-6. The safety sensors are not working, and the parts are no longer available. He did say that Elmer door believes they have some parts that should work and quoted between \$300 and \$500 to make the repairs. South Jersey Overhead Door recommended replacing the entire unit for approximately \$3000. On a motion by Mathews and a second by Cousin he was approved to get the door fixed. Vote: AIF
