

Privacy Policy

This Privacy Policy ("Policy") applies to www.AssureTherapyCenter.com, and Assure Therapy Center LLC ("Company") and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to the Company include www.AssureTherapyCenter.com. The Company's website is a Mental Health Practice site. By using the Company website, you consent to the data practices described in this statement.

Collection of your Personal Information

In order to better provide you with products and services offered, the Company may collect personally identifiable information, such as your:

- First and last name
- Email address
- Phone number

We do not collect any personal information about you unless you voluntarily provide it to us. - Mailhippo: an encrypted emailing platform. Users can utilize this email system to communicate with us through our Contact Us page. The platform encrypts your information for a secured delivery.

When personal information (such as a credit card number) is transmitted to other websites, it is protected through the use of encryption, such as the Secure Sockets Layer (SSL) protocol.

We strive to take appropriate security measures to protect against unauthorized access to or alteration of your personal information. Unfortunately, no data transmission over the Internet or any wireless network can be guaranteed to be 100% secure.
