Hi Arthur

Great to talk to you yesterday morning and find out a bit more about your proposal.

As discussed, the School Loans Scheme is an active Scheme administered by the State Government whereby concessional loans are available to support the construction of new schools and campuses, and/or upgrades to existing schools and campuses. Loans are not available to support day-to-day operations of schools or to refinance existing debt – it must be used to facilitate a specific infrastructure project.

I also advise that while the Scheme is currently not open for applications, I understand a round may be open for applications early next year.

All applications are assessed against Scheme guidelines, which includes that (among other criteria) schools be registered with the Education Standards Board (ESB), be in receipt of State Government Funding, and pass financial assessment which includes loan serviceability and security criteria.

Should the timing of your project align with a future round, I would encourage you to apply for funding so your proposal may be formally assessed. I understand the school is yet to be registered with the ESB, nor receive State Government Funding, this would need to be confirmed to be eligible to apply. A broader funding model that supports the ability to service a scheme loan, and availability of adequate security, is also integral.

Good luck with your discussions with the ESB and Department for Education. I also encourage you to enquire with the Department for Education about what other funding options may be available outside the Scheme.
