ARE LETTING AGENTS PROFESSIONAL?

agreed, bringing other agents into line with Propertymark's membership requirements.

GOVERNMENT REGULATION

ARLA Propertymark has long campaigned for financial protection for tenants and landlords.

The Scottish Government listened to our concerns and passed the Letting Agent Code of Practice (Scotland) Regulations 2016. This means that from early 2018 all letting agents will need to register and be qualified.

We think that makes perfect sense: ARLA Propertymark agents have always voluntarily chosen to do just that.
