A signed copy must be provided to students who are 18 or older, or under 18 but married or emancipated. For other minors, a signed copy must be provided to their parent or legal guardian.

Adult Waiver: Waives the 60-day Learner's Permit holding time
NOTE: Must successfully complete 36 Fifty Minute Periods of Classroom and 14 Periods (7 driving/ 7 observation) of In-vehicle instruction.
Re-Examination Courses:
8 Hour Driver Manual Course (Classroom Instruction): This course does not satisfy a Driver Improvement requirement.
NOTE: Juveniles must have already completed 36 Fifty Minute Classroom Instruction Periods prior to taking this course for three-time failures.
14 Fifty Minute In-vehicle Instruction Periods (Adult) – Driving Hours Only
14 Fifty Minute In-Vehicle Instruction Periods (Juvenile- Home Schooled) – 7 driving/ 7 observation

TERMS AND CONDITIONS

- If a student misses any instructional period, a make-up session will be scheduled, provided there is at least one other student who also requires a make-up session.
- All fees are payable in advance of the first training session. Accepted payment types are determined by the driving school.
- A refund of any fees or tuition, or any part thereof, must be provided upon request unless the school is capable and willing to perform its part of the contract within a reasonable time period.
- The driver training school does not offer refunds once services have been completed. However, refunds may be considered in specific cases on a case-by-case basis.
- Students must cancel or reschedule in-vehicle lessons at least 24 hours in advance. Cancellations made with less than 24 hours' notice will incur a \$ 25 cancellation fee.
- If the driver training school cancels a lesson, the student will be notified at least 24 hours in advance or as soon as possible in the case of an emergency. Notification will be sent via email, and the lesson will be rescheduled at a mutually convenient time.
- If a student is approved to use the driver training school's vehicle for the DMV road skills examination, a fee of \$ N/A will be assessed. This fee must be paid prior to the test date.
- Students under the age of 18 are required to meet the observation requirements with at least 1 other student during each in-vehicle observation period.
- Students under the age of 18 are required to meet the observation requirements with at least 1 other student in the road evaluation.
- Students under the age of 18 may receive one-on-one training with an instructor if such training is agreed to by the parent or guardian. The student required to meet the observation requirements with at least one other student in the road evaluation.
- The student must be 18 years old to sign this contract. If the student is under 18, a parent or legal guardian must also sign.
- The completion of a driver training program does not guarantee that any student will meet the requirements to obtain a Virginia driver's license or employment.
- Driver Privilege Card applicants must complete a road skills test at a DMV location before being licensed.

NOTE: Per Virginia Code 24VAC20-121-200, students under the age of 19 shall only receive in-vehicle instruction with other students under 19 years of age.
