Minutes:

LP made a motion to approve February 2021 minutes and GP seconded the motion, the motion to approve minutes passed at 100%

Treasurers Report: SP made a motion to close Classic Bank account and move the funds to 1st Texas Bank so that all funds are in the same place. Motion seconded by KE, The motion passed 100% in favor. CE checking into where some CD's are located.

Maintenance: LP is getting stronger everyday and should be back next month. Spring Clean-Up April 17th and bad weather make up day 4/24. GE turned in a receipt for mulch and CE cut a check to Garner Edwards. Garner plans to try to make repairs to dam when time permits.

GP reports pool is looking good and survived the ice storm. LP made a motion to increase yearly pool fee from \$150per year to \$175 per year due to the cost of maintenance. CE seconded the motion, passed at 100%

Local daycare wants to rent park on 5/26, will approve as long as a parent in the neighborhood fills out application and pays deposit.

It was discussed that there will be no outside rental of building.

Dues: rates will not be raised this year.

Treasurer: Electric bill to increase during March, PEC has raised rates

Pool Permit: GP will get with Kevin and Cliff, GP asking for \$50 to bring pool up to code, painting #'s, new float device, roping off area that needs roped off, fire extinguisher. After updates are made GP will ask for the inspection, will be \$250 for use permit for the year from Williamson county

Activities: Spring Clean -up April 17th rain make up April 24th. April 3rd Easter Egg Hunt no waiver needed due to covid restrictions being lifted for the state of Texas. May 22rd Bar-B-Q cook off. \$25 entry fee, residents/friends of residents only, deadline to register will be May 15th, will have chicken, ribs, brisket, dessert, live music at 2:30pm. People can camp / cook @ park but all cooking needs to be done over the parking lot for safety. CE will call Honey Pots @ porta-potties. Need to have an allergy statement somewhere maybe on a waiver?,
