## Maintenance:

LN reported that the scrap metal drive in April was a success. They hauled off 3 trailer and pick-up loads of metal. He will plan to schedule a fall scrap metal drive later this year. He thanked the volunteer who mowed the pool area in April and the volunteers who mowed and brush hogged the HOA grounds. He noted that the grounds have been mowed 5 times this year. He also reported that a volunteer fixed the lights in the storage shed. The volunteer park clean-up day was cancelled due to rain and he will re-schedule for Fall.
