\*Report\* On 10/10/17 at approximately 16:06 hours, I responded to 5333 Confederate Dr in reference to a Stray Aggressive investigation. Upon arrival, I observed three dogs unsupervised tethered in backyard, and took photo. I then made contact with the dog owner, Jessica Hudson and her mother Brenda Hudson. I stated DAS ACO, name, investigating complaint of stray aggressive dogs, RAL, tethering, and described RAL, aggressive animal, County license, and rabies vaccination regulations. Ms Hudson then answered my questions and stated "three dogs,.... obtained from brother in Tampa,... Sassy,... female,... intact,... Rocky,... male,... intact,... Spike,... male,... intact,... no license or vaccinations,... not sure how old,... dogs maybe four months,... phone number,... DOB." I then walked in backyard with Ms Hudson and took additional photo of tethered dogs. I then observed "Sassy", tricolor, female, Hound/mix, body condition 4-5, and took photo. I then observed "Rocky", tan, male, Hound/mix, body condition 4-5, and took photo. I then observed "Spike", tricolor, male, Hound/mix, body condition 4-5, and took photo. I then was unable to locate in database Owner ID or Animal ID. I then created Owner ID (P142664), Animal IDs (A227292, A227293, A227294) and Tag Screens. Based on the investigation, I determined a violation had occurred. I then issued NTC for unsupervised tethering. I then provided Know the Law brochure and gave verbal warning to obtain County license and rabies vaccination or may result in citation for each violation. Ms Hudson then signed each citation. I then stated please confine the dog or walk on a leash, and any evidence of dogs RAL or aggressive behavior may result in citation/fine for each violation. I then re-sequence to follow up on NTC for unsupervised tethering. The case was closed with no further action. 135/TB

\*Report 1\*

On 2/27/18 at approximately 14:54 hours, I responded to 5333 Confederate Dr in reference to 3 sig 31 dogs. Upon arrival, I was unable to make contact with the owner, Jessica Hudson-P142664. I witnessed 3 tri colored hound mix dogs tethered unsupervised in the yard. Each dog seems to have a baby pool with water near it and a small amount of shade. Outside temp is 84 degrees F. I found the matching dogs linked to Ms. Hudson, Sassy-A227292, Spike-A227294, Rocky-A227293. Ms. Hudson has previously been issued NTC for unsupervised tethering. All the dogs are current on rabies, but not lic. The dog on the side of the yard had an entangled chain, causing it to only be able go about two feet, out of reach of the baby pool. The water in the baby pool was brown and full of dirt/mud. The water in the baby pool by "Sassy" is semi dirty, but drinkable. The water in the baby pool by "Rocky" is clean, but in full sun. There are empty bowl, presumably food bowls by each dog. The area where "Spike" is has a large hole dug under the sidewalk by the house. I spoke with 138/DG and decided to confiscate the dog, Spike-A227294, a M tri colored shepherd mix. I scanned for a microchip with negative results. While I was printing the citations for "Sassy" and "Rocky" 2nd offense unsupervised tethering and NTC for license and 2nd offense unsupervised tethering, tethering without access to food, water, shelter, entangled tethering, and confinement without access to food/water/shelter for "Spike". The owners mother, Brenda Hudson, came home. I made contact and advised her of the issued. She stated they'd gotten a kennel for the dog, but they'd chewed out of it. She said "they love the dogs and take care of them". I showed her the dirty water in the pool for "Spike" and she said it's because he gets in the pool. I explained that I'd confiscated him due to the entangled tether and tethering without access to water. She and the children were upset. She then showed me the kennel, which was a chain link kennel on a concrete slab with a large hold in the concrete. She and a male resident stated they did have the dogs in the kennel, but they'd chewed out. I asked if the dogs ever get out to play ect. The male stated they "chain the dogs out twice a day to go to the bathroom" I told him that the reason the dogs are probably being destructive is due to boredom. I gave them some suggestions for toys that dispense treats to keep the dogs busy. 137/HM

The family started cleaning up the yard to move the kennel to the grassy area where they could bury panels so the dogs couldn't dig out. I obtained signed copies of all citations/NTC and explained how to comply along with a NTC instruction sheet, licensing partnership sheet, and VSA/CSNC info. I also gave her a notice of impoundment for "Spike" and contacted Gerilynn at the front desk for a rough estimate of the fees to claim him~\$150 if they came tonight. I also obtained a signed copy of an OTPC for the kennel due 3/6/18. 137/HM

On 3/7/18 at approximately 18:46 hours, I responded to 5333 Confederate Dr in reference to a follow up on a kennel. Upon arrival, both Sassy and Rocky were still tethered, but the family was outside with them. I made contact with the owner Jessica Hudson and her mother, Brenda, who stated they'd gotten the kennel done, but the power was out so they hadn't moved the dogs. The power was out when I arrived and they stated it'd been out since around 2 pm. Sassy is in heat, so they are going to be keeping her in the house. Brenda showed me the kennel, which had been moved to the sand/dirt area. They had boards on two of the sides and had ziptied them up. There was one area that still needed fortified, so I helped patch it up with zipties. We moved the baby pool, food bowl, and water bowl in the kennel and placed Rocky inside. Jessica stated she was going to be getting another kennel from petco this week for Sassy. They stated they wanted to get Spike back and were going to get him from HSN tomorrow. I also explained the NTCs and citations/RPO class to Jessica, as she was not there when they were issued. She stated she will be in tomorrow to get the licenses and sign up for the RPO class. Because they took the steps to get the kennel up, I told her I'd see if Dan could remove all the citations instead of just two. I will send him an email. Right before I left, Jessica came up and showed me that she'd ordered the kennel for Sassy. 137/HM

On 3/21/18 at approximately 18:14 hours, I responded to 5333 Confederate Dr. in reference to 2 tethered dogs without shelter. Upon arrival, I saw Sassy and Rocky tethered in their usual places. Sassy had food, but no water and Rocky had water, but no food. I made contact with the dog owners mother, Brenda Hudson. She stated Jessica Hudson, owner, was at work. I have had multiple dealings with the Hudson's on this issue. I told her I've given them so many chances to fix the issue. She stated Rocky broke out of the fortified kennel and mated with Sassy (his sister) and she believes Sassy is pregnant. I explained this is one of the reasons people have to be responsible pet owners, spay/neuter, why we have tethering laws ect. She said "I know, I know". She said Sassy has been staying in the house and she was tethered just so she could "eat and use the bathroom". She admitted that Rocky has been tethered for 2 days, but she put him on the covered porch during the storm last night. I asked about the kennel Jessica stated she'd ordered during my last visit and Brenda said she didn't know. Brenda also stated that Jessica signed up for the RPO class, but when she showed up, they said she wasn't registered. I asked if she paid the \$40 fee and she hadn't. I explained the fee had to be paid up front. I told her this was no way for dogs to live, they get no attention. Rocky has been on the chain so long, that he has hair missing on his chest from jumping up and the chain rubbing. She admitted they don't have time for the dogs, "but they love the dogs". Brenda said she has to take care of her grandchildren and the house ect and she just found out she has a broken bone in her back. She stated at this point she wanted me to just take the two dogs. I told her she could owner surrender the dogs for \$10 each at the shelter, but if I took them tonight the fee would be around \$120. I told her I could try and call my supervisor and get some of the fees waived, but she didn't want to go through with it while Jessica wasn't home. I told her I'd give her until Fri to either owner surrender the dogs, get a new kennel, or give them to someone else. Failure to do so would result in 3rd offense citations for unsupervised tethering, tethering without access to food/water/shelter, and 1st offense breeding without a permit would be issued. I made her put both dogs inside the house (different rooms) before I left. 137/HM

Mr Santos then answered my questions and stated "my phone 239-248-8657,... the dogs are friend of my sister-in-law,... she dropped them off,... not know the name of the dog owner,... she is on vacation,... dog owner is a black girl,... sister-in-law is looking after the dogs for her,... she is at work,... Melissa Batsel,... 239-227-0771." Mr Cavazos then answered my questions and stated "male dog name is Rocky,... not know the female dog name,... she (Ms Batsel) look after them (dogs)." I then observed "Rocky", large size, brown/white, male, Hound mix, body condition 5, and took photo. The dog is fearful and I was unable to fully scan it in the kennel for a microchip. The male dog appeared to have knocked over it's water bowl that was now empty. I then observed large size, brown/white, female, Hound mix, body condition 5, and took photo. The dog is fearful and I was unable to fully scan it in the kennel for a microchip. The female dog had full water bowl. I then was unable to make contact by phone with Ms Batsel. I then was unable to leave voicemail because it is not set up. I then provided Know the Law brochure and Notice stating "Please contact DAS regarding two dogs observed/photo in kennels. Failure to comply with this request may result in citation up to \$500.00 for each violation." I then filled up the water bowl of the male dog. Based on the investigation I determined that the two dogs are in good condition and confined in kennel of size that meet or exceed the minimum standards of care. I looked at the pictures attached to the activity and recognized the two dogs as Sassy-A227292 and Rocky-227293. From the picture, I could see that Sassy was pregnant. (See previous activities involving the dogs for backstory). I arrived at 3705 Thomasson Dr and made contact with the caretaker, Melissa Batsel-P147014. I confirmed that the dogs were Sassy and Rocky, owned by Jessica Hudson-P142664. Both dogs were in the crates, as they were the last time 135/TB was out, but both had full water bowls. Rocky spilled his when I walked up. I saw a sturdier bowl with food and suggested to Ms. Batsel to put the water in that bowl which she did. She stated that Ms. Hudson's landlord told them they had 3 days to get rid of the dogs or move, so she is watching them until they can move into their new house on June 4th. Ms. Batsel stated she comes out all the time and lets the dogs out to run around, but Sassy has just been staying in her kennel [REDACTED]. She stated Sassy is afraid to go in the house without Rocky. Rocky is too rowdy for Ms. Batsel to bring in the small house. I asked Ms. Batsel to call Ms. Hudson on her phone, so she'd answer. I spoke with Ms. Hudson and told her I was a bit angry at the fact Sassy was [REDACTED] after all the options I gave her. I told her she would be receiving breeding without a permit citations for each puppy. She stated she took responsibility for what happened. He also stated that the [REDACTED] dog, Sassy-A did have 8 puppies, but the dog is no longer on the property. Rocky is still on the property at 3705 Thomasson Dr. He said he will try to find out where they took Sassy and call back. I created bite card and explained the quarantine procedure. I tried to make contact via phone with the dog owner, Jessica Hudson, but there was no answer. I left a message regarding Rocky and asked that she call back. I arrived at 5333 Confederate Dr. and all the vehicles were in the driveway. I knocked on the door multiple times, and could hear people inside, but no one came. Then two men drove up and I thought they were friend of the family, so I got back out to see if they'd answer the door for them. The man stated one of the children from 5333 Confederate Dr, stole his daughters cell phone at school and they'd tracked the phone to the residence. They were also unable to get anyone to answer the door. I called CCSO and they were also unable to get anyone to answer the door. I gave them Ms. Hudsons info. Reseq. to try and make contact. I left my card and a notice on the door to contact us.

While I was pulled over Ms. Hudsons sister, Janita Zaely, came outside. She was in the shower while everyone was knocking on the door. I advised her of the bite with Rocky and she stated both Rocky and Sassy are still on Thomasson. I explained the quarantine procedure and obtained a signed copy. Due to previous escaping of Rocky, I told her he needed to be quarantined at DAS or Vet today or tomorrow, 5/10/18 by 5 pm. She said she would have Jessica bring Rocky in and possibly owner surrender him. She also confirmed Sassy had 8 puppies, 6 F 2 M. I will follow up with them on Sunday. 137/HM
