Building Reopening Plan (Revised 2021)

Three Phases

Guidelines for In-Person Worship in the WSUMC Sanctuary

What will happen on Sunday mornings?

Personal Preparation

- Congregants are advised to wear masks and to bring their own Bibles to worship services. Congregants will need to wear a mask, covering nose and mouth, while in the church building.
- Congregants are advised *not* to wear gloves, in order to avoid cross-contamination.
- Children are encouraged to attend worship services with their families, as childcare will not be provided at this time.
- Parishioners are encouraged to stay home if they or someone in their household feel ill or have underlying medical concerns that increase vulnerability. Worship services will be livestreamed online on the Wall Street United Methodist YouTube channel, so that those who need or want to stay home can still join their church family in worship.

Before the Worship Service

- Congregants are urged to observe good public health practices in the church parking lot (e.g., maintaining 6-ft social distance, wearing masks).
- Entrance to the church building will be available at the double doors under the overhang in the parking lot and at one set of doors off the front porch.
- Doors will be propped open whenever possible to minimize the number of people touching handles.
- Church leaders, wearing masks, will provide hospitality at entrances, reminding parishioners of necessity of public health practices (e.g., maintaining 6-ft social distance, wearing masks) and monitoring capacity.
- Tables will be stationed at entrances with hand sanitizer and individually packaged masks for those who need them.
- Access to the building will be limited to the sanctuary and surrounding areas, including rest rooms. Church offices, kitchen, and Sunday School rooms will be closed.
- Congregants will proceed directly to the sanctuary, rather than gathering in common areas. No coffee or refreshments will be provided.

During the Worship Service

- Congregants will be seated in every other pew. Individuals and family groups will maintain a 6-ft minimum social distance. Four tables will be available in the Family Worship Area.
- These measures would allow us to accommodate approximately 60 people during the worship service. Seating in the sanctuary will be limited in order to accommodate social distancing.
- Additional socially distanced seating will be available in Fellowship Hall, where congregants can watch the worship service live stream in the event that the sanctuary seating capacity is reached.
- The worship service will be broadcast to the church parking lot via FM radio, so that people may worship in their cars if they prefer. This provides another option for worshippers in the event that the sanctuary seating capacity is reached.
- Parishioners are reminded that we are to avoid greetings that involve physical contact.

- No bulletins will be distributed. All announcements and worship information will be on the screens.
- Pew Bibles and hymnals will be removed. Congregants are encouraged to bring their own Bibles from home.
- Pulpit and lectern will be arranged so that the pastor and liturgist can sit separately and maintain a 6-ft social distance from each other and other congregants. Worship leaders will wear masks when not speaking.
- The music director and organist will also maintain 6-ft social distancing.
- There will be no choral or congregational singing.
- Offerings will be received at stations located throughout the sanctuary. Offering plates will not be passed from hand to hand.
- Worship services will be abbreviated to approximately 45 minutes in duration.
- Worship services will continue to be available online on the Wall Street United Methodist Church YouTube channel.

After the Worship Service

- Congregants will be dismissed by rows, beginning from the back of the sanctuary.
- All are asked to exit the church directly, rather than gathering in common areas indoors. Socializing in the parking lot, while observing appropriate safety precautions, is encouraged instead.
- Trash cans will be available in the parking lot for the disposal of single-use masks and sanitizing wipes.

Additional Information

- The parish nurse will coordinate communication with the Clark County Health Department as needed and will oversee contact tracing procedures if a congregant tests positive for COVID-19.
- All processes and procedures during Phase 1 – including the start date – are subject to change as guidelines and information are received from church and civic leaders.
- Timeline for moving into Phase 2 of this reopening plan is dependent on the implementation of and adherence to Phase 1 plans and to recommendations from church and civic leaders.
