CONDITIONS OF CONSENT

1. This consent is valid only for the approved production capacity of RUBBER COMPOUND-03 M.T./DAY, TYRE RECYCLING -05 M.T./DAY .
2. This consent is valid only for products and quantity mentioned above. Industry shall obtain prior approval before making any modification in product/ process /fuel/ plant machinery failing which consent would be deemed void.
- 3(a) The maximum rate of emission of flue gas should not be more than the emission norms for the stacks.

- 3(b) Air Pollution Source Details.

4. Quantity of other pollutants should also be as per the norms prescribed by the Board/MOEF & CC/or otherwise mandatory .
5. The equipment for air pollution control system and monitoring ,as proposed by the industry and approved by the Board should be installed in their premises itself .
6. The modification or installation in the existing pollution control equipments should be done only by prior approval of Board .
7. The operation of air pollution control system and maintenance be done in such a way that the quantity of pollutants should be in accordance with the standards prescribed by the Board/MoEF & CC/or otherwise mandatory .
8. Unit should do provisions for fugitive emissions chimney/stack as per the norms of the Board/MOEF & CC/or otherwise mandatory .
9. The unit should submit the stack emissions monitoring report within one month from issuance of consent order along with the point wise compliance report of the consent order . Further quarterly monitoring report should be submitted .

The Unit will file the renewal application at least 2 months prior to the expiry of this Order.

Specific Conditions:

This Consent is granted on the recommendation of RO and subject to following conditions: This Consent/Renewal of Consent is for:

- a) The Compliance to the norms for emission as prescribed in schedule-1 of environment (protection) Rules, 1986 as may be prescribed by the Board.
 - b) Noise and ambient air quality to be maintained within Ambient Air Quality Standards for noise as specified in schedule III of afore said Rules.
 - c) The effluent (domestic /industrial) conforming to the limits as prescribed in Schedule-I or Schedule-VI of Environment Protection Rules 1986 as amended or as may be prescribed by the Board.
1. Pollution Control Devices provided by the Unit shall be operated and maintained to achieve the norms as prescribed in Environment (Protection) Act, 1986 as amended from time to time.
 2. The State Board reserves the right to revoke/review and alter the conditions of consent as the case may be.
 3. Unit shall not undertake the expansion activity/ or additional product in the existing Unit without obtaining consent from State Board.
 4. Unit Shall not discharge any kind of Industrial effluent.
 5. This consent is only Valid for Domestic Discharge.
 6. Unit shall comply with the Hazardous Waste (Management, Handling & Transboundary Movement) Rules, 2016.
 7. Unit Shall comply all the provision of Plastic Waste Management Rules, 2016.
 8. Unit shall comply all the provisions of Solid waste Management rules 2016.
 9. Unit shall not pollute any water sources in the area like drinking source, pond or well etc.
 10. Unit Shall develop green belt 10 meter or 33% of Total area (whichever is less).
 11. Unit shall maintain the stack height of D.G. set as per EPA Norms.
 12. No debris shall be thrown along the roads or water course and the debris shall be either utilized or disposed in designated dumping sites.
 13. No change or alteration of the industrial plant is to be made without the prior permission of the Board. Any change in the particulars furnished and/or in the identity of the occupier/authorized agent is to be intimated to the Board forthwith.
 14. The project proponent shall be liable to clear any past/current liability on account of difference consent fees if detected at any subsequent stage.
 15. In case of process disturbance/failure of pollution control equipments, the respective Units shall be shut down and shall not be restarted until the control measures are rectified to achieve the desired efficiency.
 16. If operations are planned to be done with backup power, the generator shall have adequate capacity to run all the associated pollution control devices.
 17. There shall not be any fugitive emission from the plant or premises.
 18. Arrangements of rainwater harvesting shall be provided and maintained.
 19. This consent can be Revoked if a public Grievance is received and confirmed against the industry
 20. The emission/effluent shall be got sampled and tested by the Unit as well as concerned Regional Office as prescribed and further renewal shall be dependent up on the results of samples so collected and tested.
 21. Adequate fire protection equipment shall be provided in the Unit and the Unit shall submit NOC from the Department of fire & safety.
 22. Unit shall submit map of unit approved by competent authority within 03 months.
 23. The unit shall installed water meter on the water intake point.
