## **September Program:**

# LITIGATION ON BEHALF OF 9/11 VICTIMS AGAINST THE MULTIPLE DEFENDANTS INCLUDING THE SAUDI GOVERNMENT AND OTHER ENTITIES ACCUSED OF SUPPORTING TERRORISM.

A member of our organization who has worked on the well-known pending international lawsuit captioned <u>Burnett v. al Barka Investment</u>, shares his experiences and inside knowledge about the case. The case was brought on behalf of more than 6,500 families of the 9/11 victims against countries, banks, charities, individuals, and organizations who are accused of supporting and financing the attack.

#### About Our Speaker - Anthony M. Sellitto, Jr

#### Member of the Association of Retired Attorneys of Sarasota

Anthony M. Sellitto Jr, Tony to his friends and colleagues, practiced law in New Jersey until his retirement on disability in 2013.

Anthony graduated from Villanova University in 1968 with a Bachelor of Science degree in Biology. He has been married to his wife Cornelia for 38 years and has two sons, a step-son and two grandchildren and has lived full time in Sarasota since 2014.

Anthony received a JD degree from Seton Hall University School of Law in 1971. He was admitted to practice law in New Jersey, the U.S. District Court for the District of New Jersey and the U.S. Supreme Court. He served a judicial clerkship under the Hon Joseph B Sugrue, Criminal Assignment Judge of Essex County New Jersey. Mr. Sellitto then spent 2 ½ years as an Assistant Prosecutor in Union County New Jersey during which time he tried over 50 jury trials. Mr. Sellitto was one of the first attorneys in New Jersey to become certified by the New Jersey Supreme Court as both a Civil and Criminal Trial Attorney.

Anthony's practice concentrated on plaintiff's personal injury claims, criminal defense and workers compensation. He was a member of the Board of Governors of the New Jersey chapter of the American Association for Justice, formerly the National Association of Trial Lawyers of America – New Jersey.

Anthony has lectured on the use of technology in the courtroom at continuing legal education seminars conducted by the New Jersey, Wyoming and National Associations for Justice. He was the first attorney in New Jersey to use Power Point in a summation; the first to use Zoom for a plea in court for an out of state defendant. He was also the first attorney in New Jersey to prepare a video settlement brochure and the first settlement brochure on CD.

On September 11, 2001 Anthony's cousin Matthew Carmen Sellitto was murdered in the terrorist attacks on the World Trade Center. Prior to his retirement, Mr. Sellitto was co-counsel in the case of Burnett v Al Baraka Investment, a lawsuit filed on behalf of over 6,500 family members of those who were killed on that day. The suit was the brainchild of Ron Motley Esq, lead attorney in the suits by the 36 states that successfully sued the tobacco industry in 1998. Defendants include the Kingdom of Saudi Arabia, Iran, Sudan and the banks and charities that funded and provided other assistance to the terrorists. The lawsuit is still pending in the Federal District Court for the District of Columbia and is part of a Multi District Litigation case venued in the Southern District of New York that manages all civil suits arising out of the terrorist attacks. Anthony conducted the direct testimony of Matthew's father, Matthey T. Sellitto, a transcript of which was read at the trial of Mounir el-Motassadeq, roommate of terrorist Mohammad Atta that took place in Hamburg Germany in 2003. el-Motassadeq was convicted as an accessory to murder for assisting the 9/11 hijackers.

Outside of the courtroom, Anthony had a multi-disciplined athletic career. While at Villanova he was a member of the 1967 & 1968 National Championship Cross Country Teams and 1968 National Championship Indoor Track Team. He was the 1967 US Junior National 10,000 Meter Race Walk Champion. He spent his summers during college as an ocean lifeguard in Spring Lake New Jersey and was certified by the Red Cross as a water safety and swimming instructor. After college, he took up skiing and was certified as a ski instructor US Eastern Ski Association. Mr. Sellitto raced slalom, giant slalom and downhill while attending law school and was a member of the National Ski Patrol. Mr. Sellitto taught skiing on the weekends while he served his judicial clerkship. Mr. Sellitto also swam Masters and was third in the 1984 Middle Atlantic Masters 500 meter freestyle.

Anthony was a Lieutenant in the South Orange New Jersey Auxiliary Fire Department and was a member of the Clark New Jersey First Aid Squad.

Since his retirement Anthony spends his leisure time fishing, as a nature photographer and as a grandpa!
