About Our Speaker – Ric Kearbey

Senior Scientist, Climate Adaptation Center, Inc.

Ric Kearbey is a veteran meteorologist who has spent the last two decades informing and educating the public about weather and climate issues on local and network television. His television work has been recognized as the best in the market on multiple occasions, as voted by local television viewers. His scientific work has been seen nationally on Good Morning America, ABC's World News Tonight and in major television markets including Tampa, Florida and St. Louis, Missouri.

Ric has provided important game forecasts for the NFL's Super Bowl and the PGA's Masters Tournament. He has written and contributed to many climate and weather related stories for television and print media, including the Tampa Bay Times. His work has been featured on radio stations all over the country.

Amicus Personae – Geraldine A. Roberts

Member of the Association of Retired Attorneys of Sarasota

Gerri was born in Newington, CT to Irish immigrant parents. After graduating from Mt. St. Joseph Academy, she attended St. Joseph College (now known as the University of St. Joseph) in West Hartford, CT where she majored in History with a minor in Political Science. After college Gerri began her career with the State of Connecticut and became the Assistant Personnel Administrator for the Connecticut State Police Department. During that time, she also attended the University of Hartford where she received an M.P.A in Public Administration with a concentration in Labor Relations. Subsequently, she decided to attend law school and graduated from Western New England University School of Law in 1982. Gerri then began her employment with the Connecticut Department of Mental Health where she served as a Senior Executive Service Manager.

She believes in the importance public service and giving back to one's community, so she became involved local politics, and was appointed to various town boards and commissions. She was elected to the Wethersfield Town Council where she served several terms. She also was elected to the Wethersfield Board of Education, becoming the Chairperson twice.

Gerri played a prominent role in women's issues in Connecticut, beginning with her appointment to the Connecticut Permanent Commission on the Status of Women. During her 16 tenure, including 2 terms as Chairperson, many important pieces of legislation were enacted, including the nation's first Family and Medical Leave Act in 1987. She has served as the Secretary of the National Association of Women's Commissions. Gerri was appointed to the Chief Justice's Task Force on Gender, Justice and the Courts which examined bias and discrimination in the Connecticut judicial system and recommended strategies to make the system more just.

After a 36-year career in Personnel Management and Human Resources in various state agencies, Gerri retired and has pursued many interests, such as watercolor painting, joining book clubs, learning to speak Italian as well as playing the bagpipes. She is serving her third term on the University of St. Joseph Board of Trustees. She and her husband, retired Police Chief Ed Brymer, have been snowbirds since 2014 and love living at Stoneybrook Golf and Country Club. They have 2 adult children, and 3 wonderful grandchildren. Last year they were blessed with the addition of their first great-granddaughter, Hadley, who is the light of their lives!
